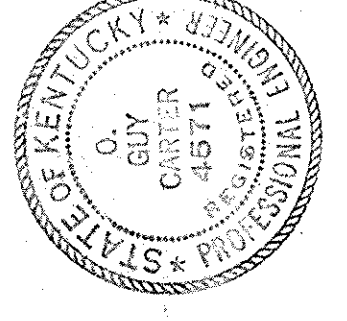


PARTIAL PLAN SECTORS 6-1 & B

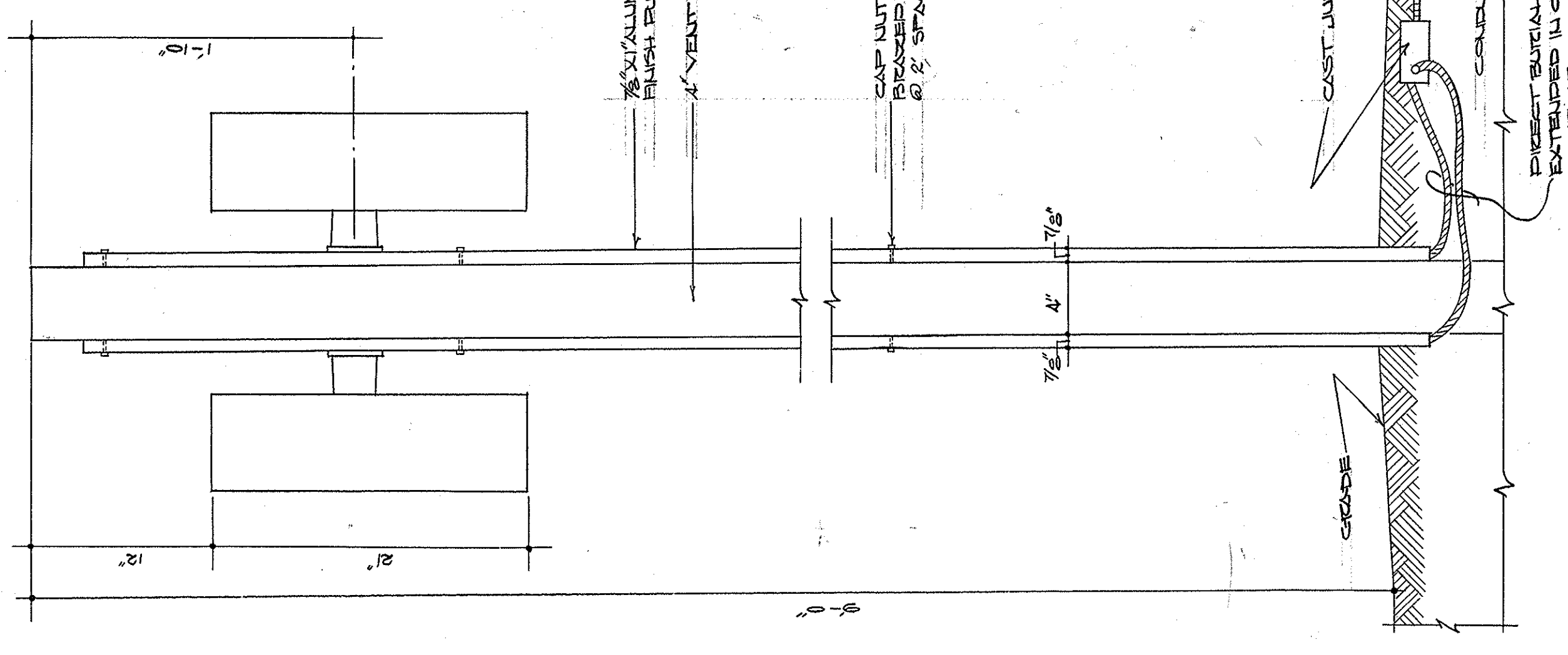

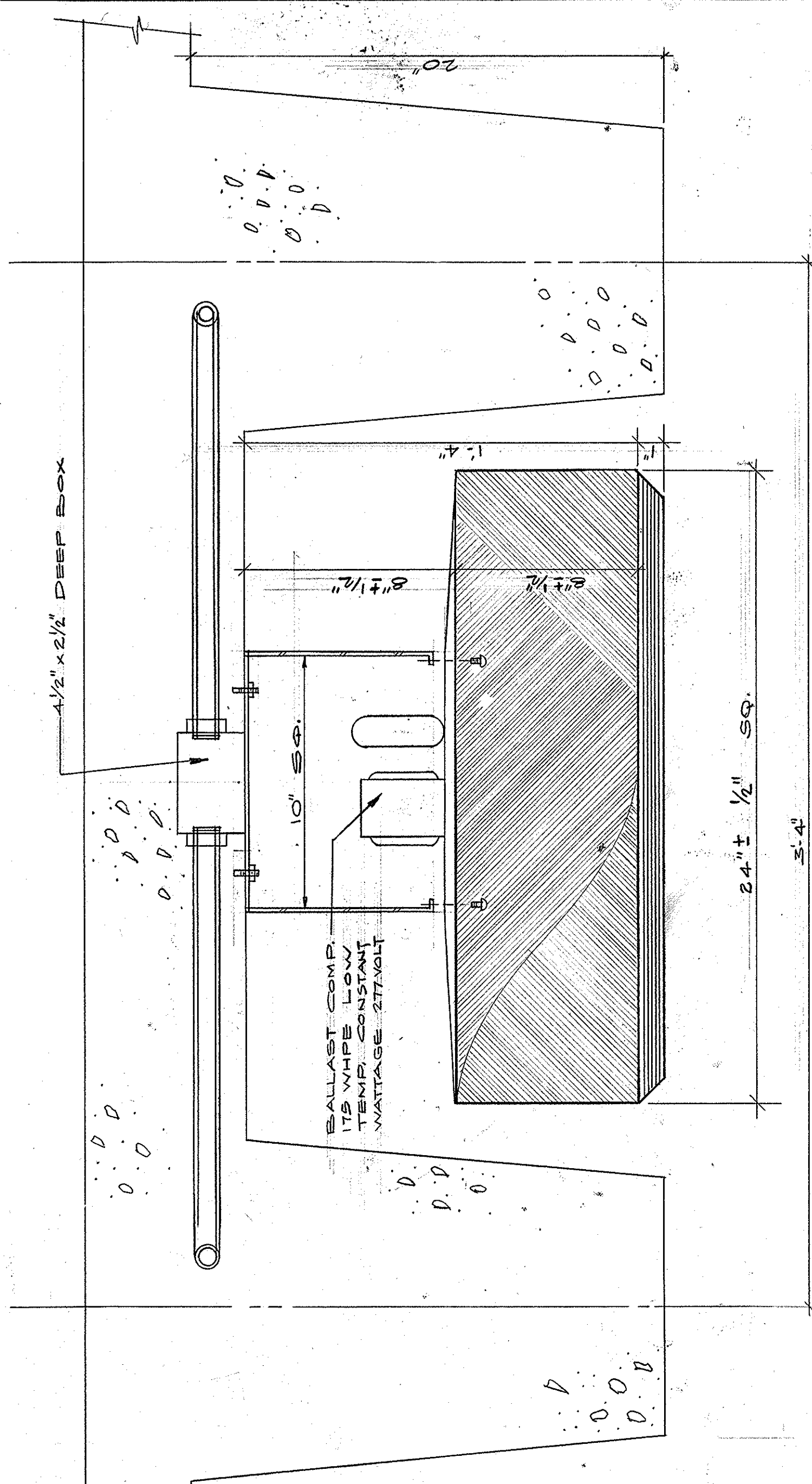
ELECTRICAL PLAN - GROUND LEVEL - SECTOR N° C-C

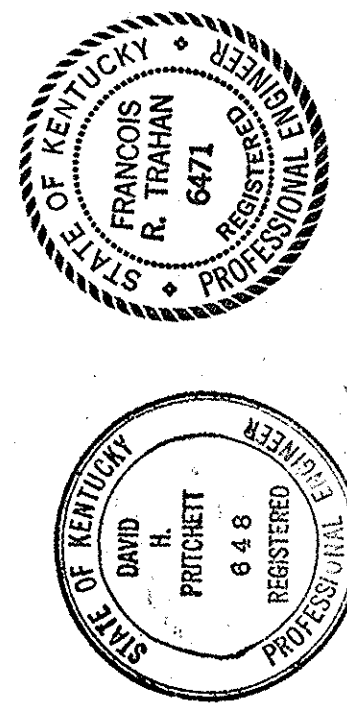


DETAIL - FIXTURE "GA"

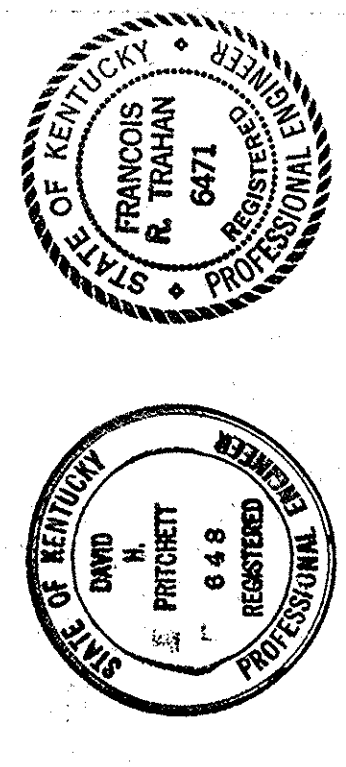


TELEPHONE RACEWAY RISER DIAGRAM

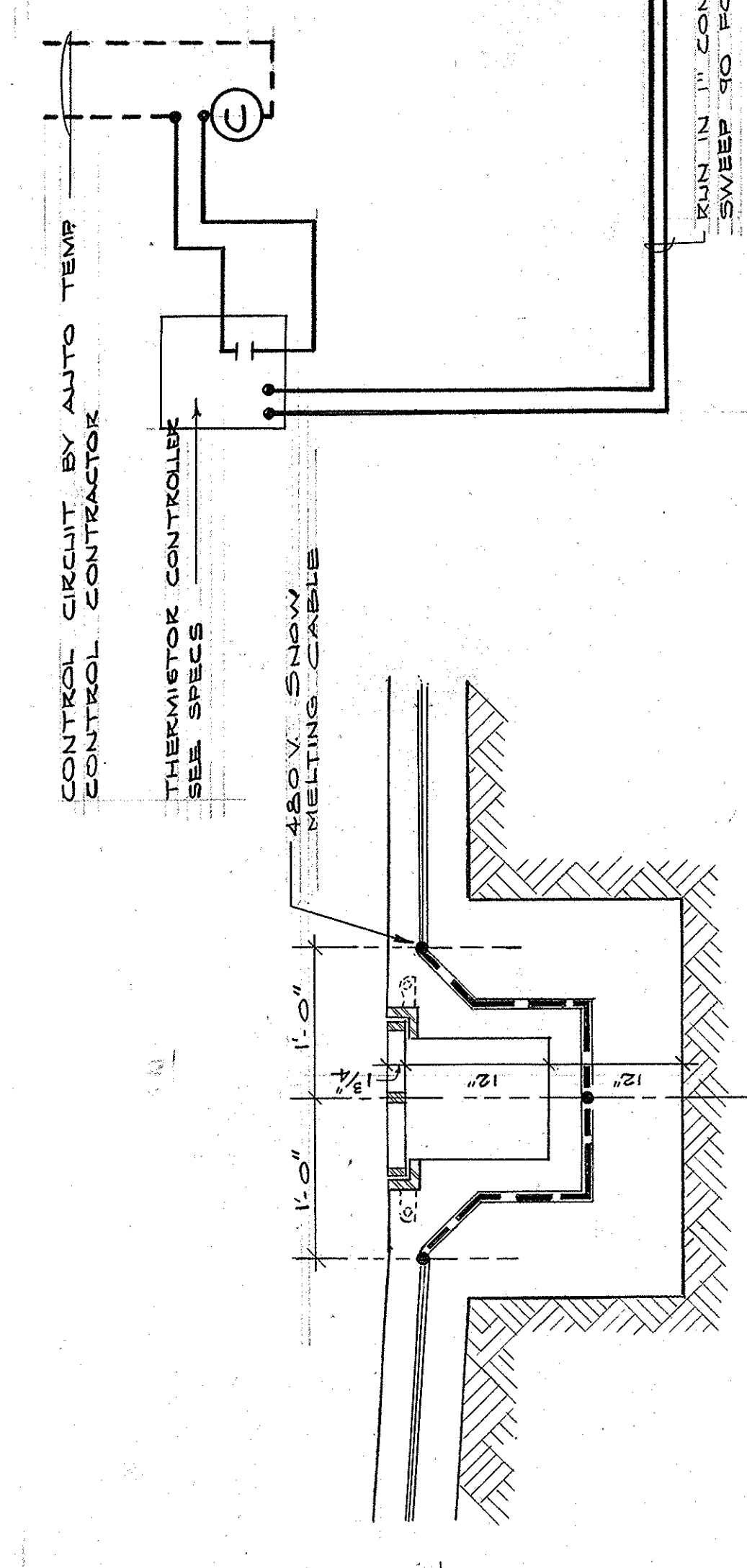
ELECTRICAL PLAN - POWER - MEZZANINE LEVEL - SECTOR D-5

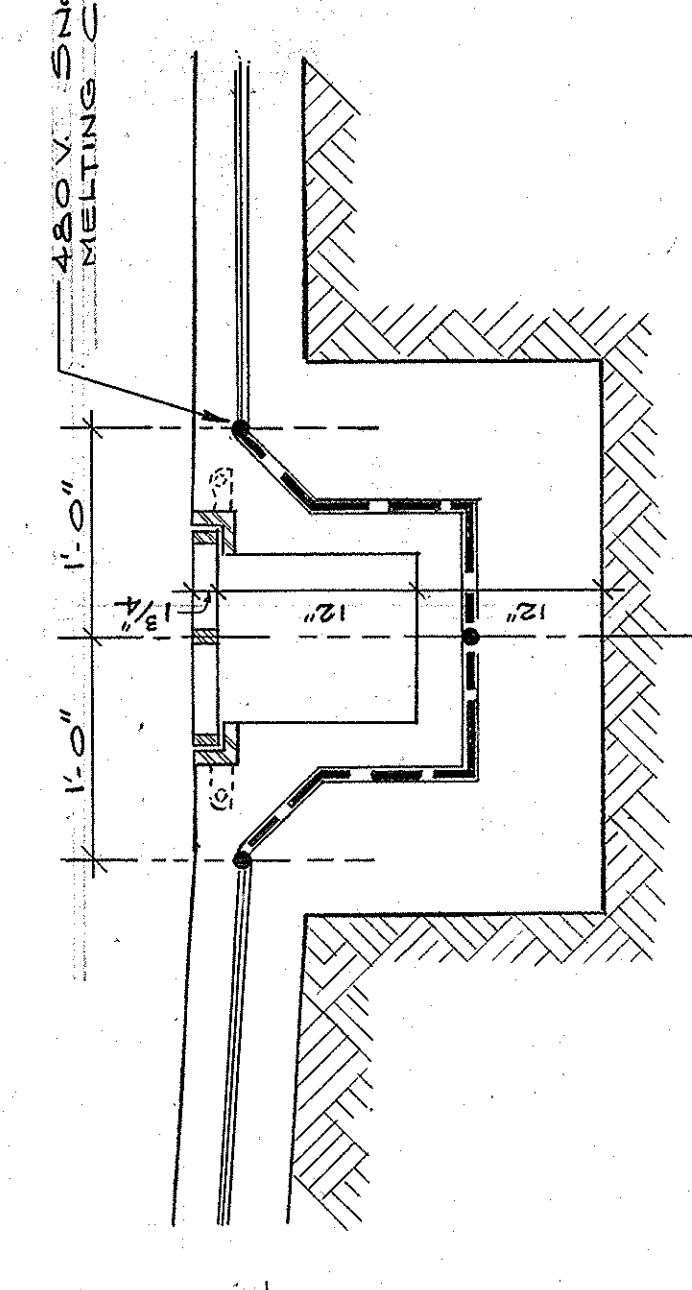
ELECTRIC HEATING CABLE PLAN - SECTOR D-4 - LOADING DOCK

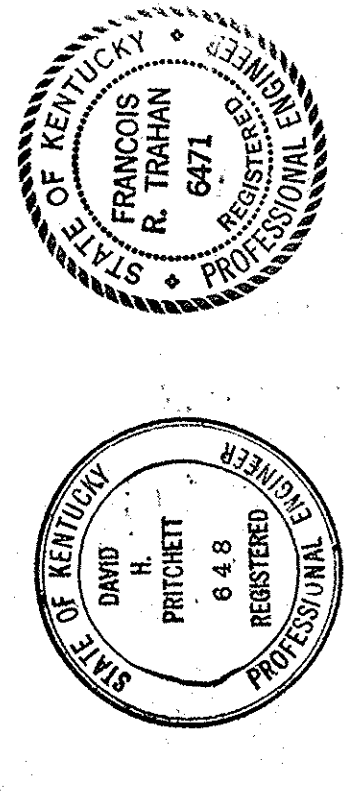


CABLE CONNECTION DIAGRAM - RAMP D-4 & D-5

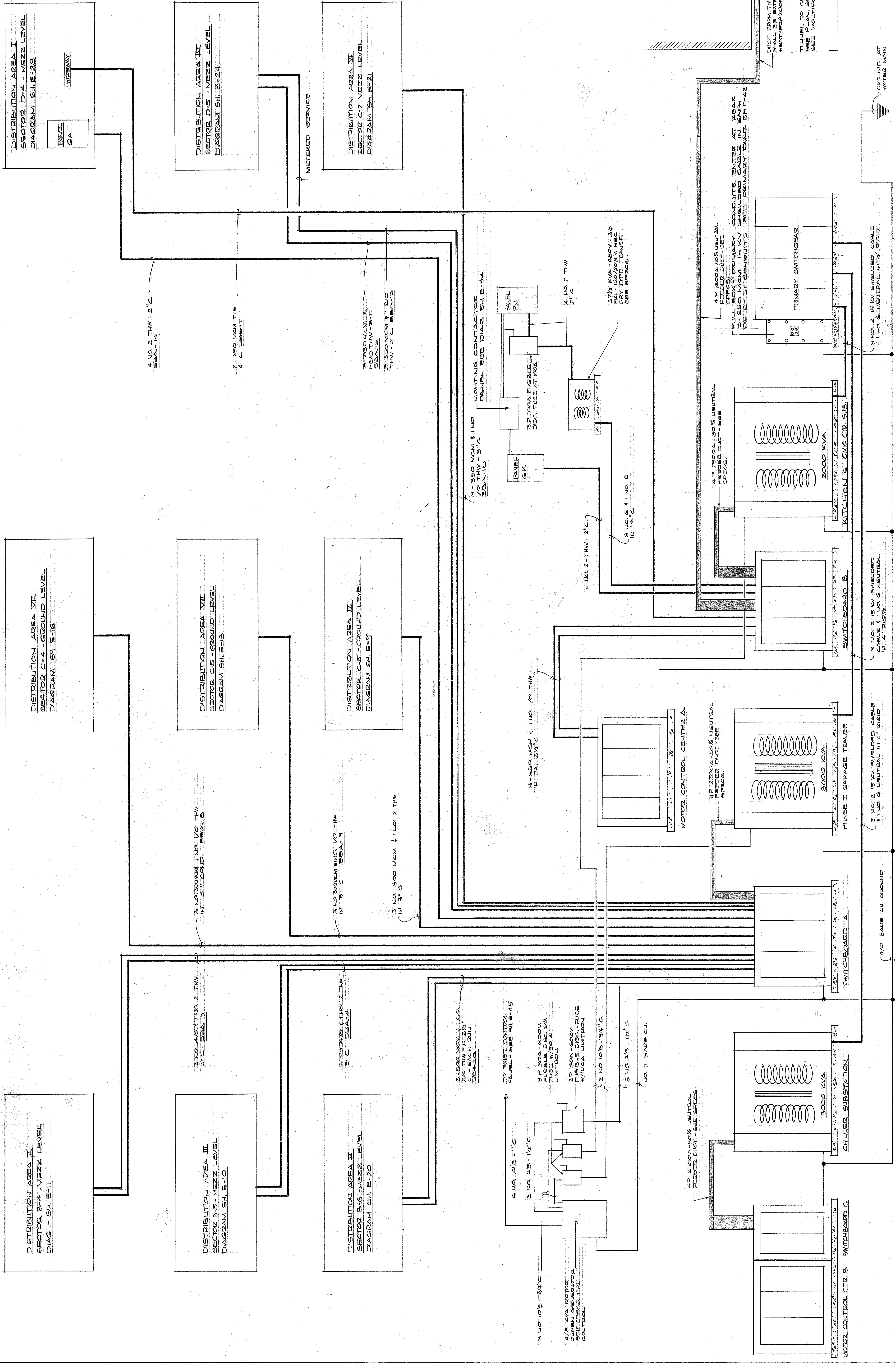

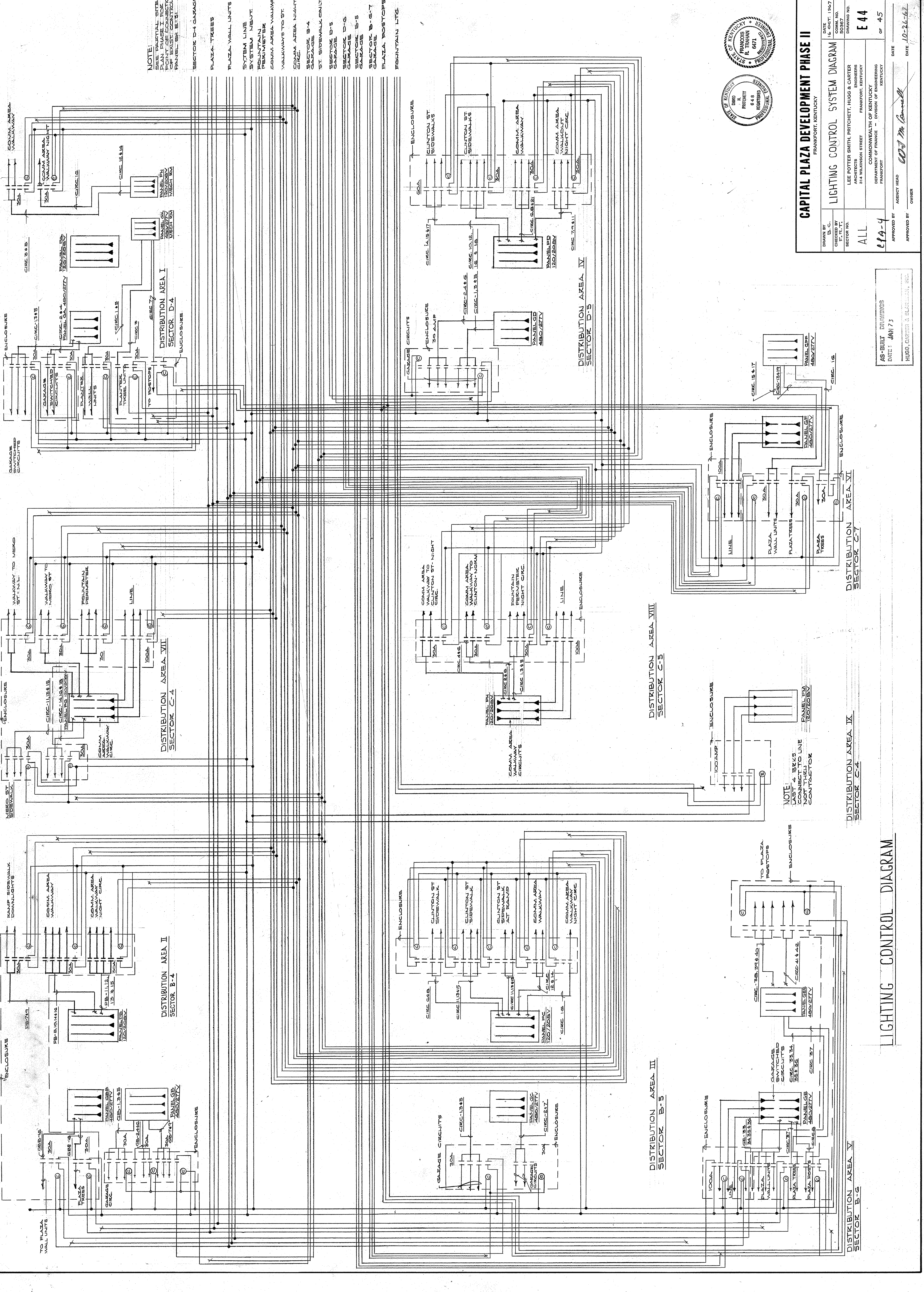
ELECTRICAL PLAN - PLAZA LEVEL - SECTOR D-5

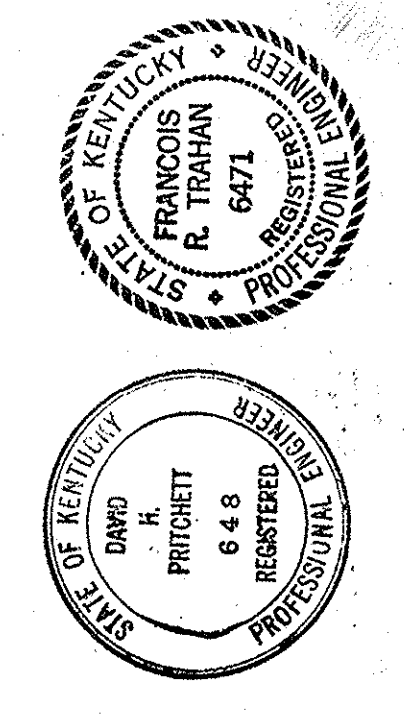
SERVICE AND FEEDER RISER DIAGRAM
