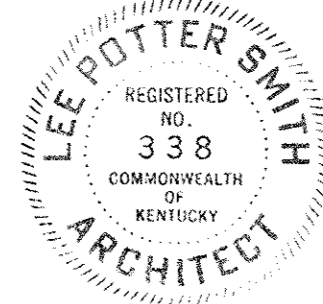
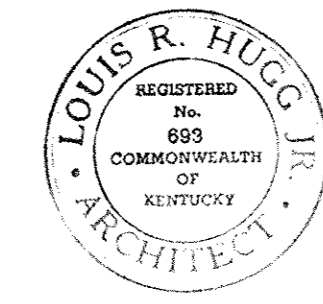
DIAGRAMMATIC 'AS BUILT' LOCATION OF BUILDING

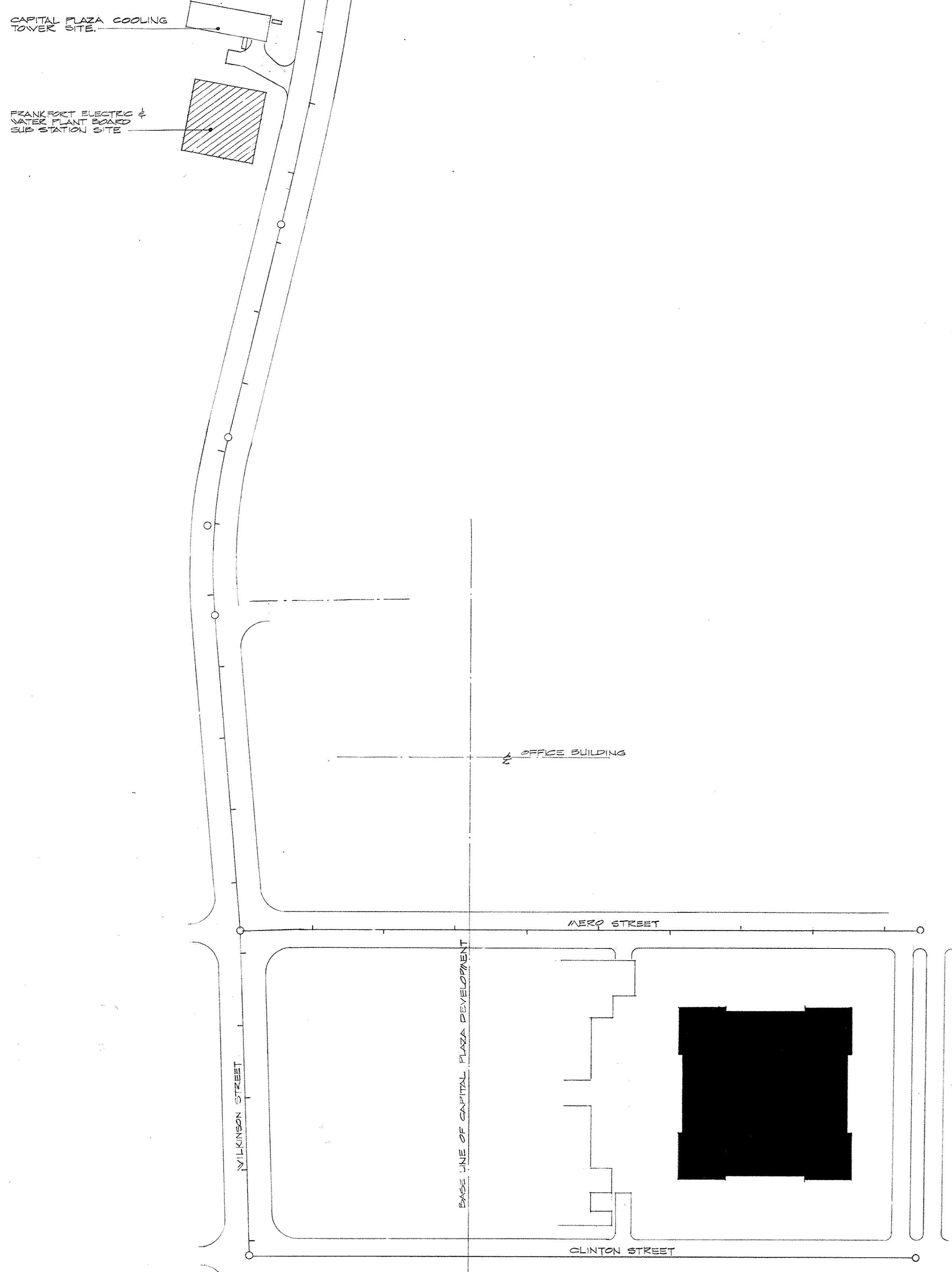

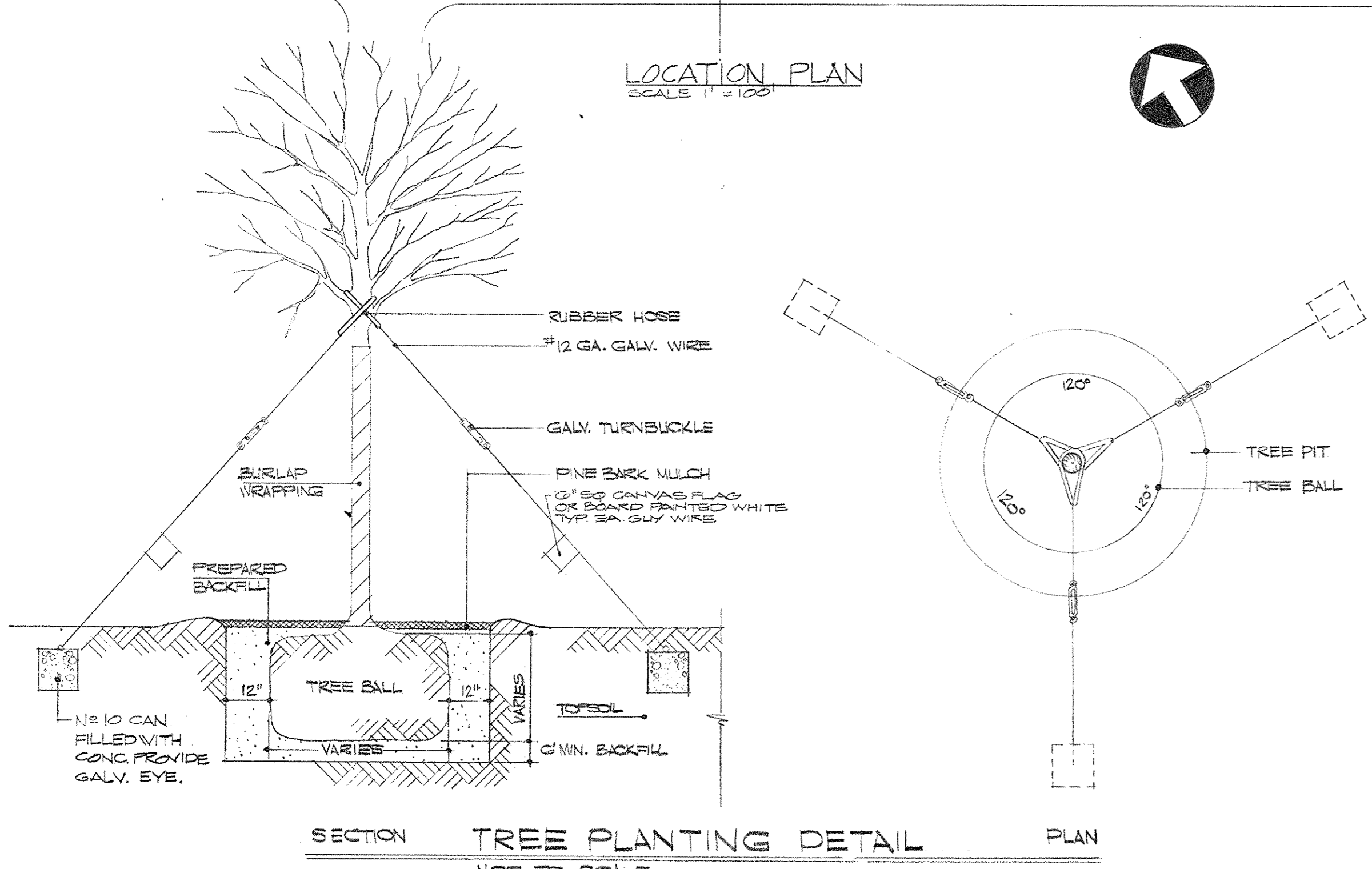

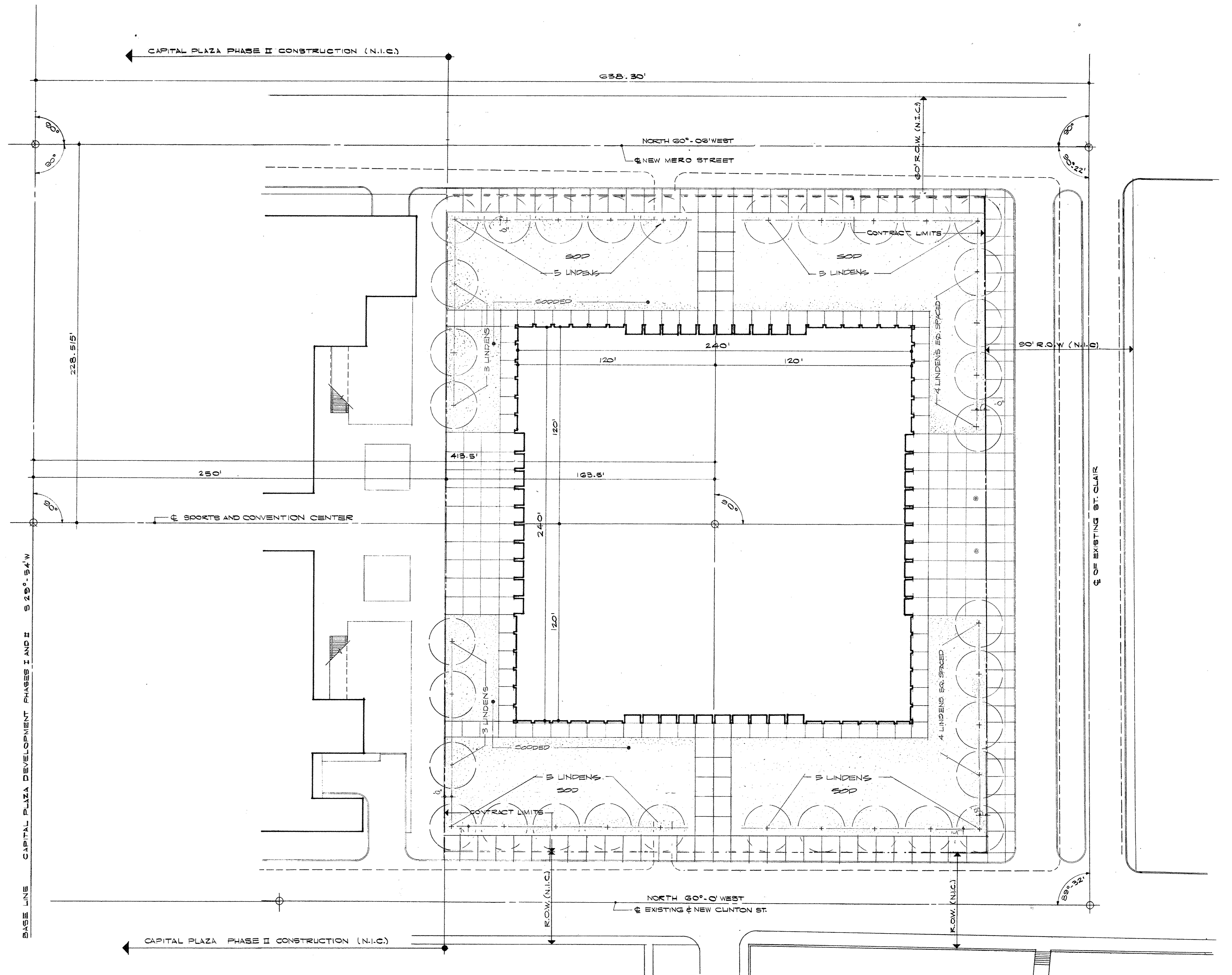




LOCATION PLAN

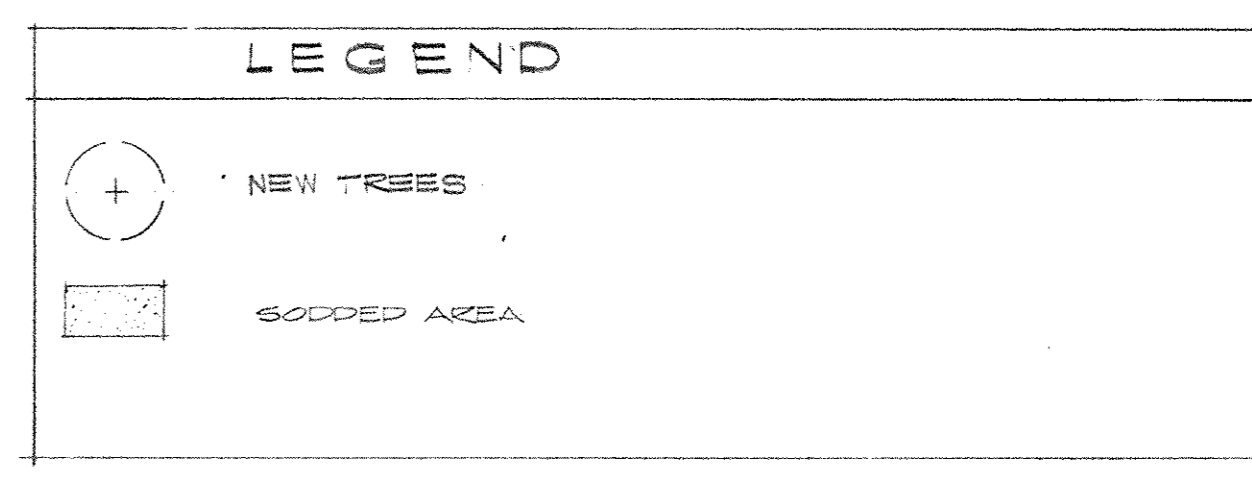


SECTION TREE PLANTING DETAIL

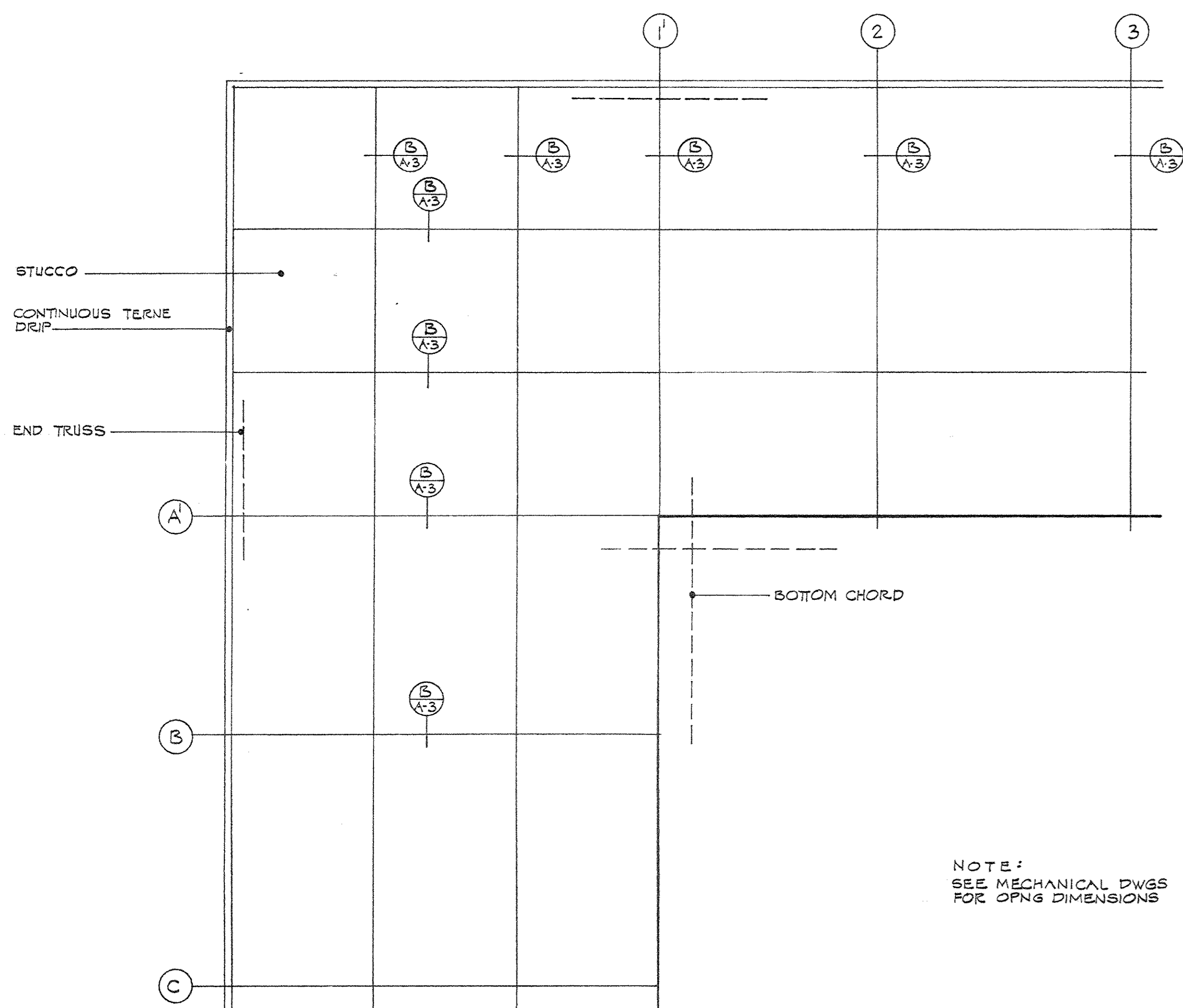
EAST AND WEST ELEVATIONS

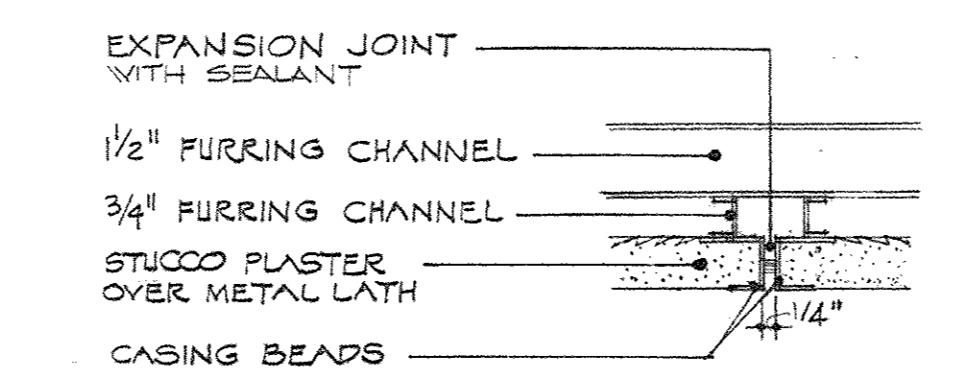

PARTIAL REFLECTED SOFFIT PLAN

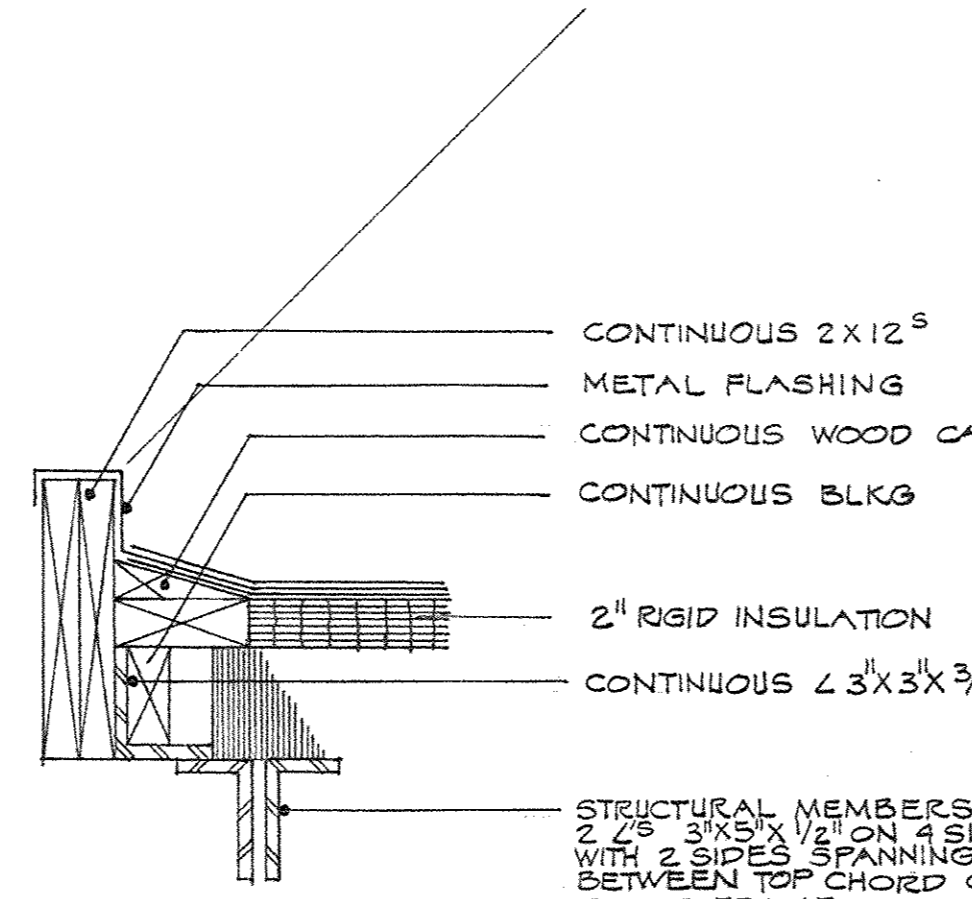

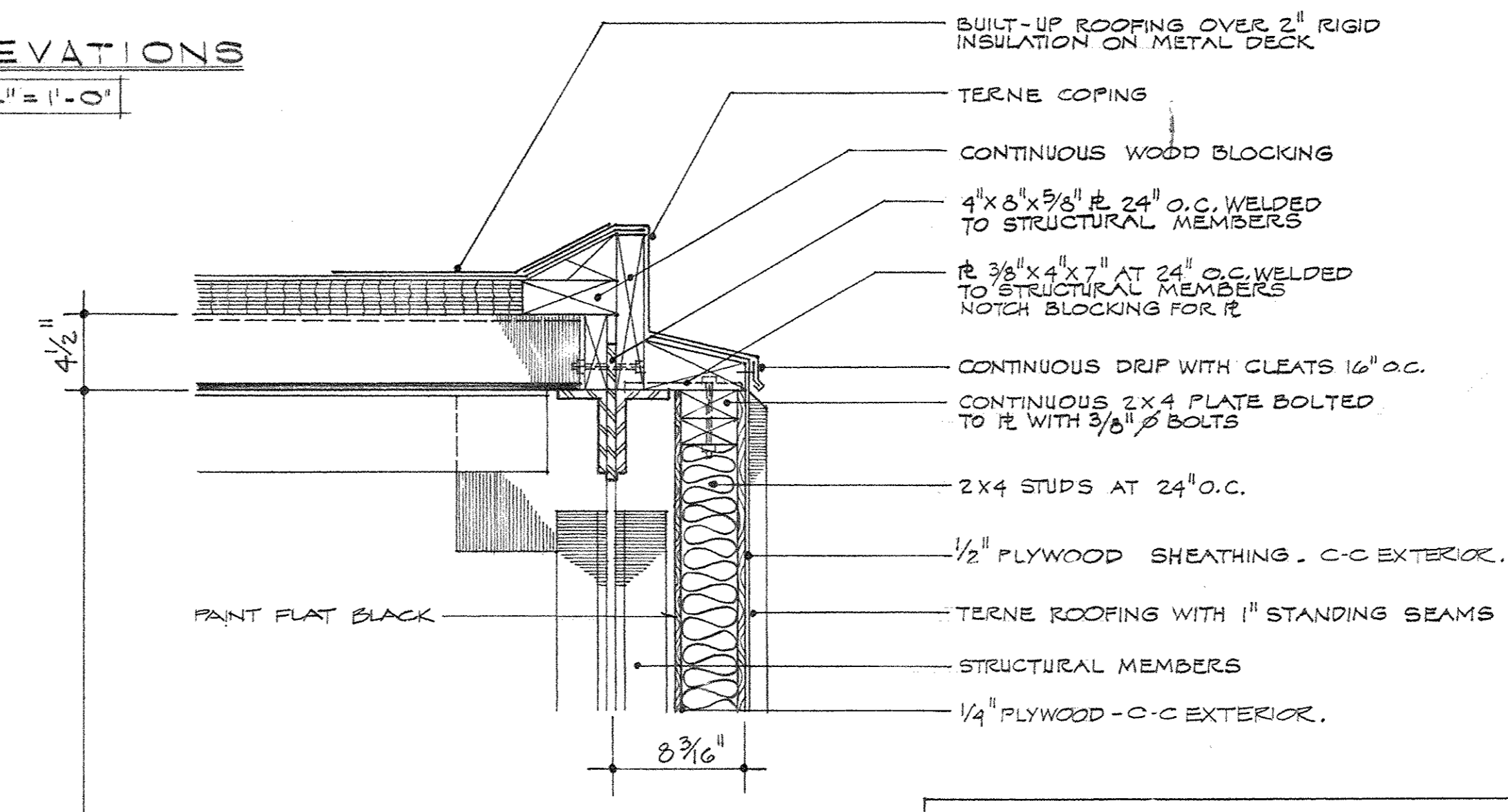

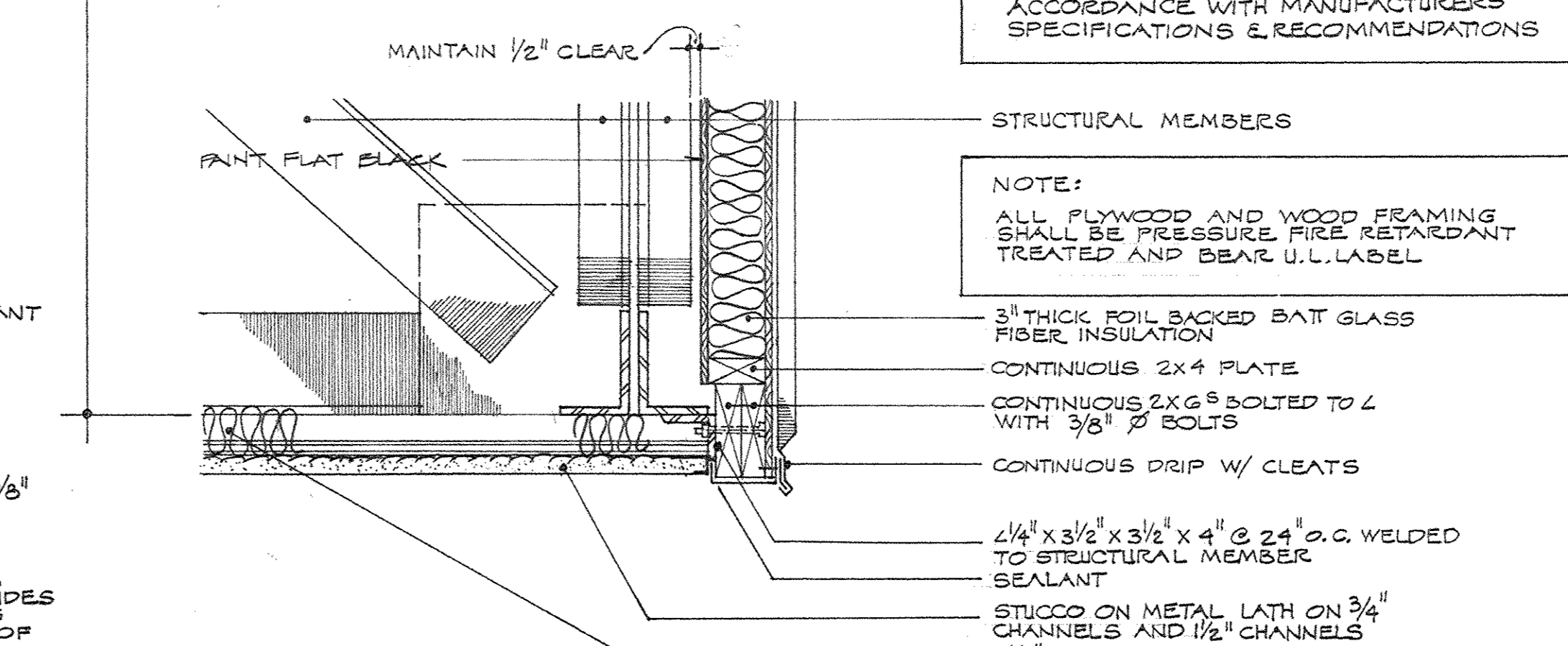
D A-3 CURB DETAIL

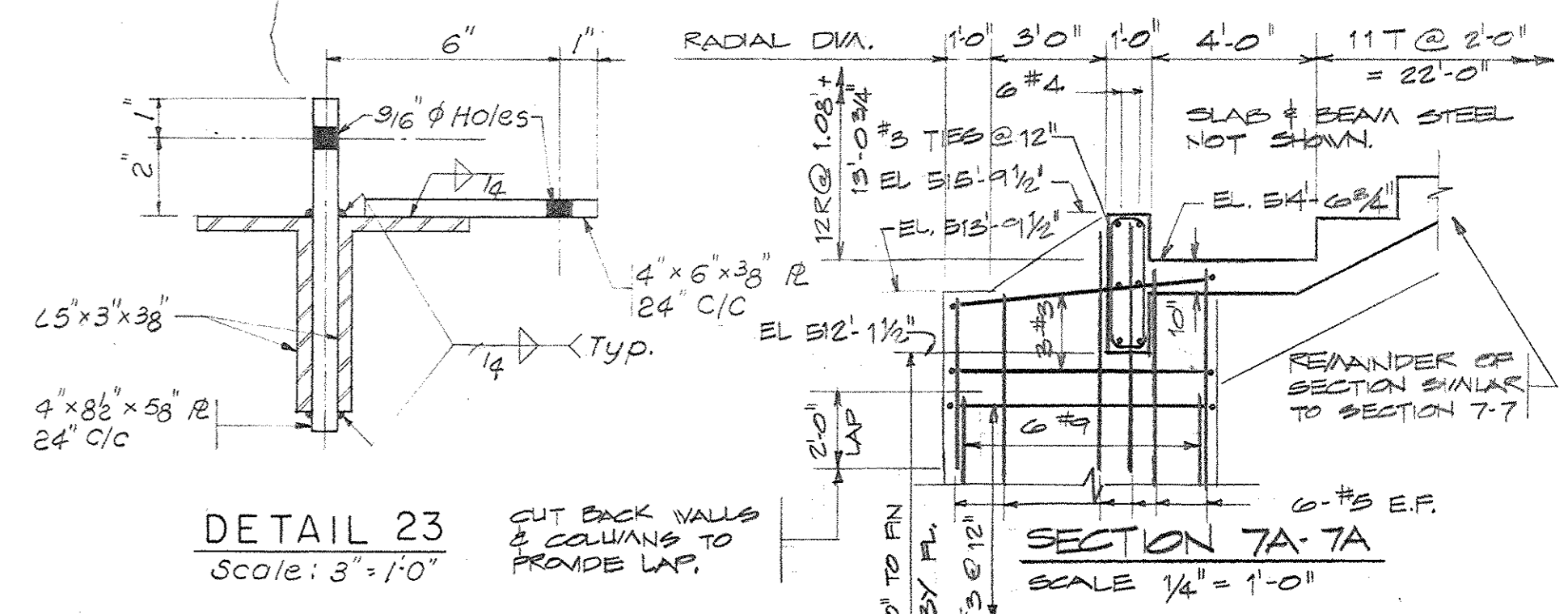
TYPICAL DETAIL WHERE SLABS

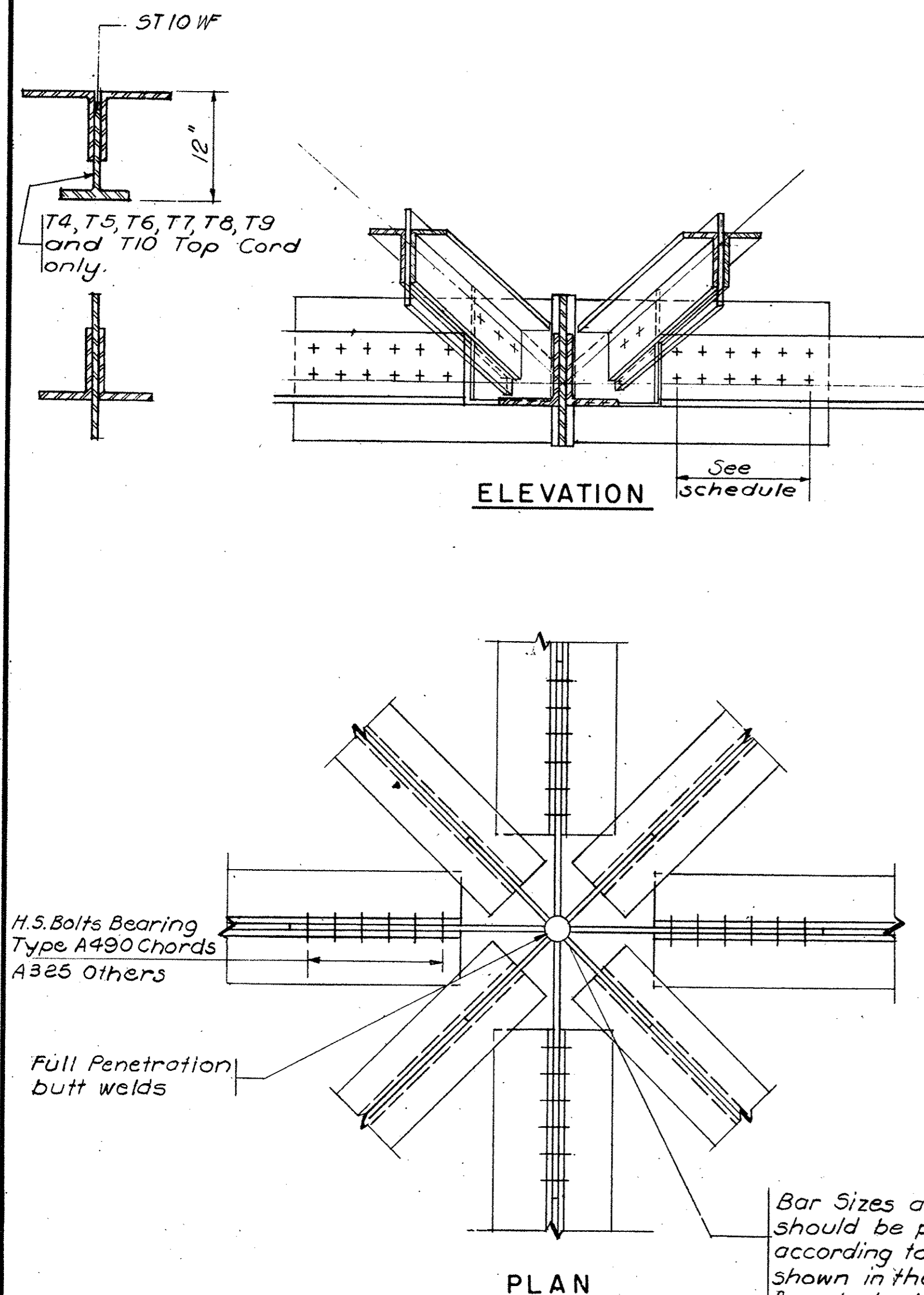
TYPICAL EXTERIOR WALL DETAILS



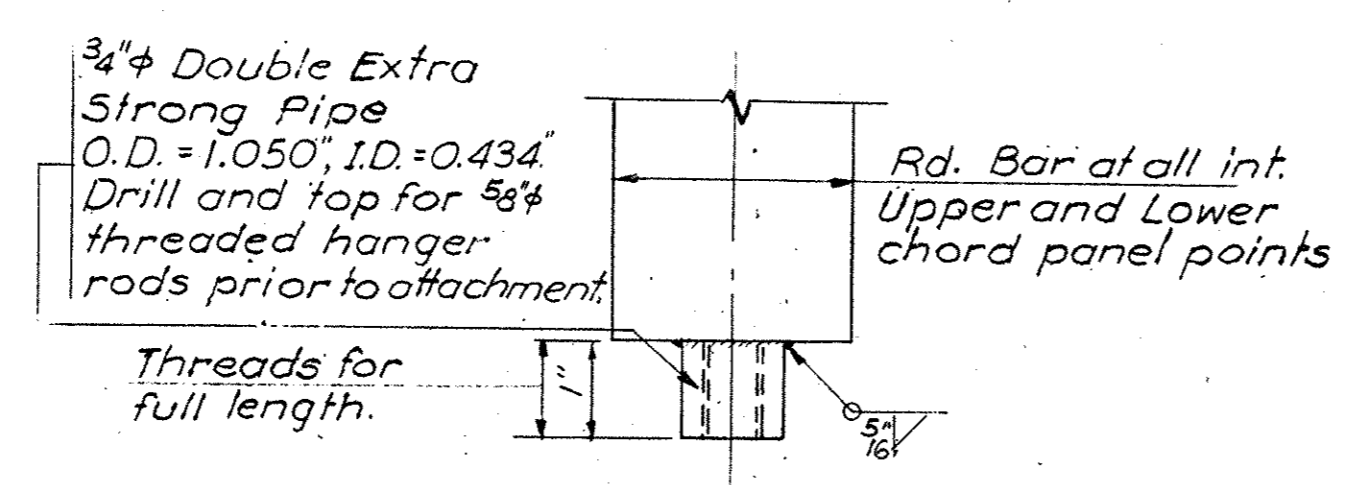

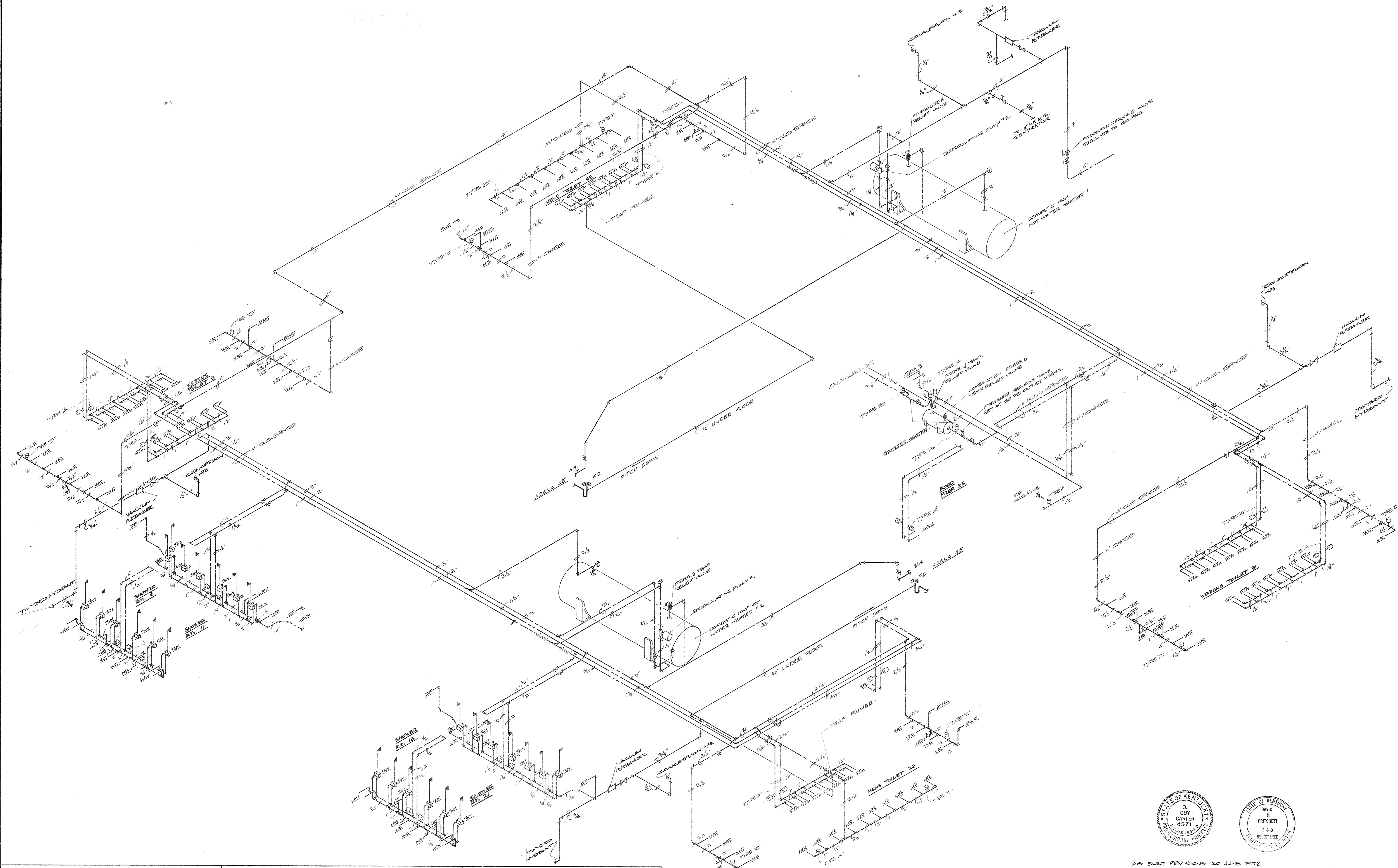


WASTE & VENT PIPING DIAGRAMS

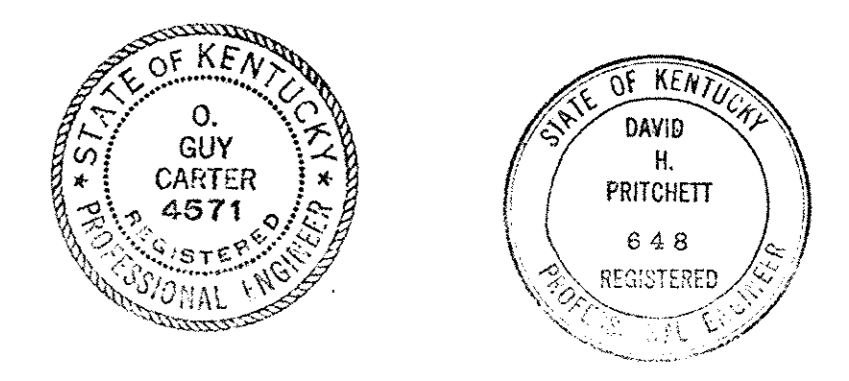

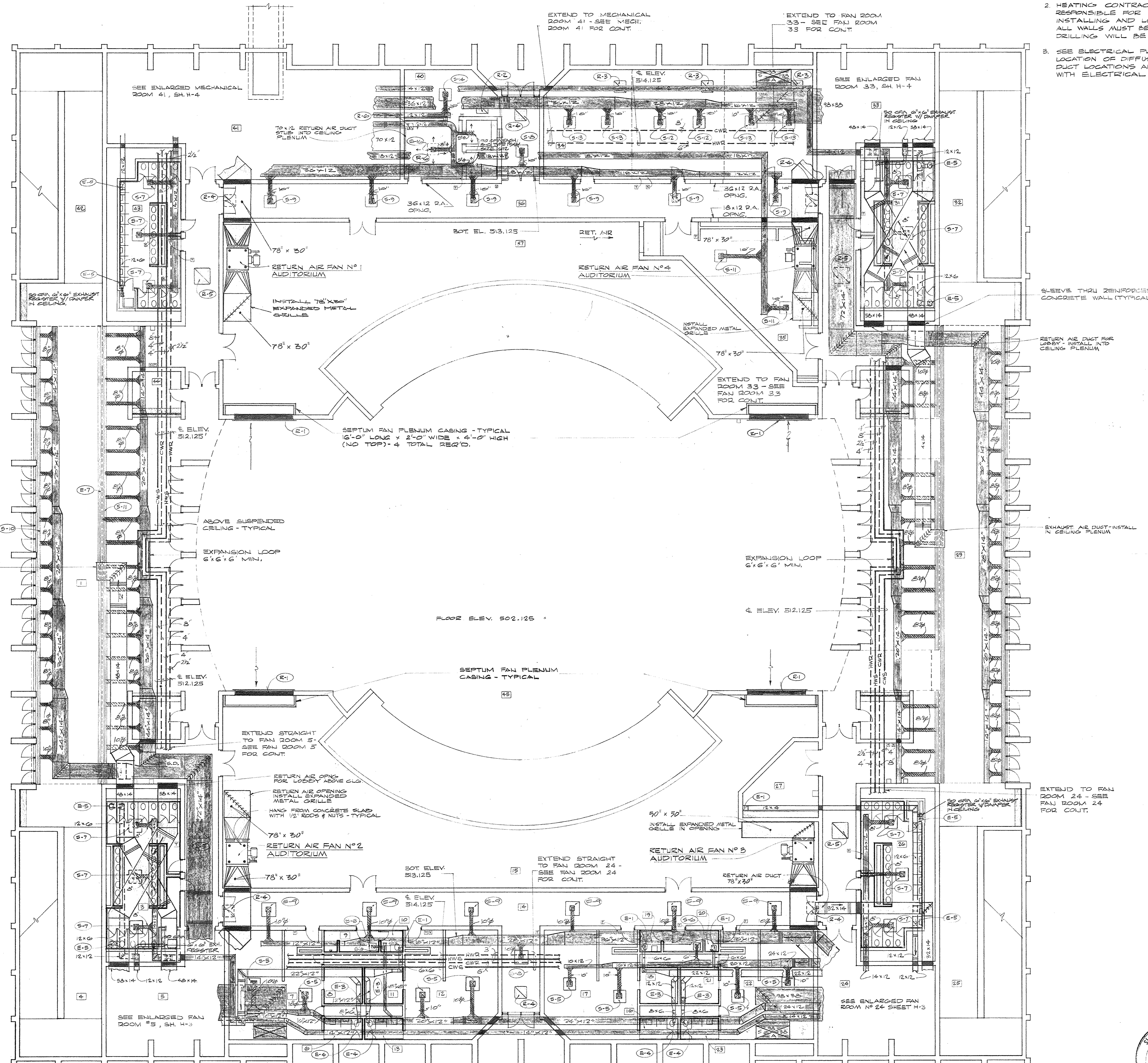
DOMESTIC WATER PIPING DIAGRAM

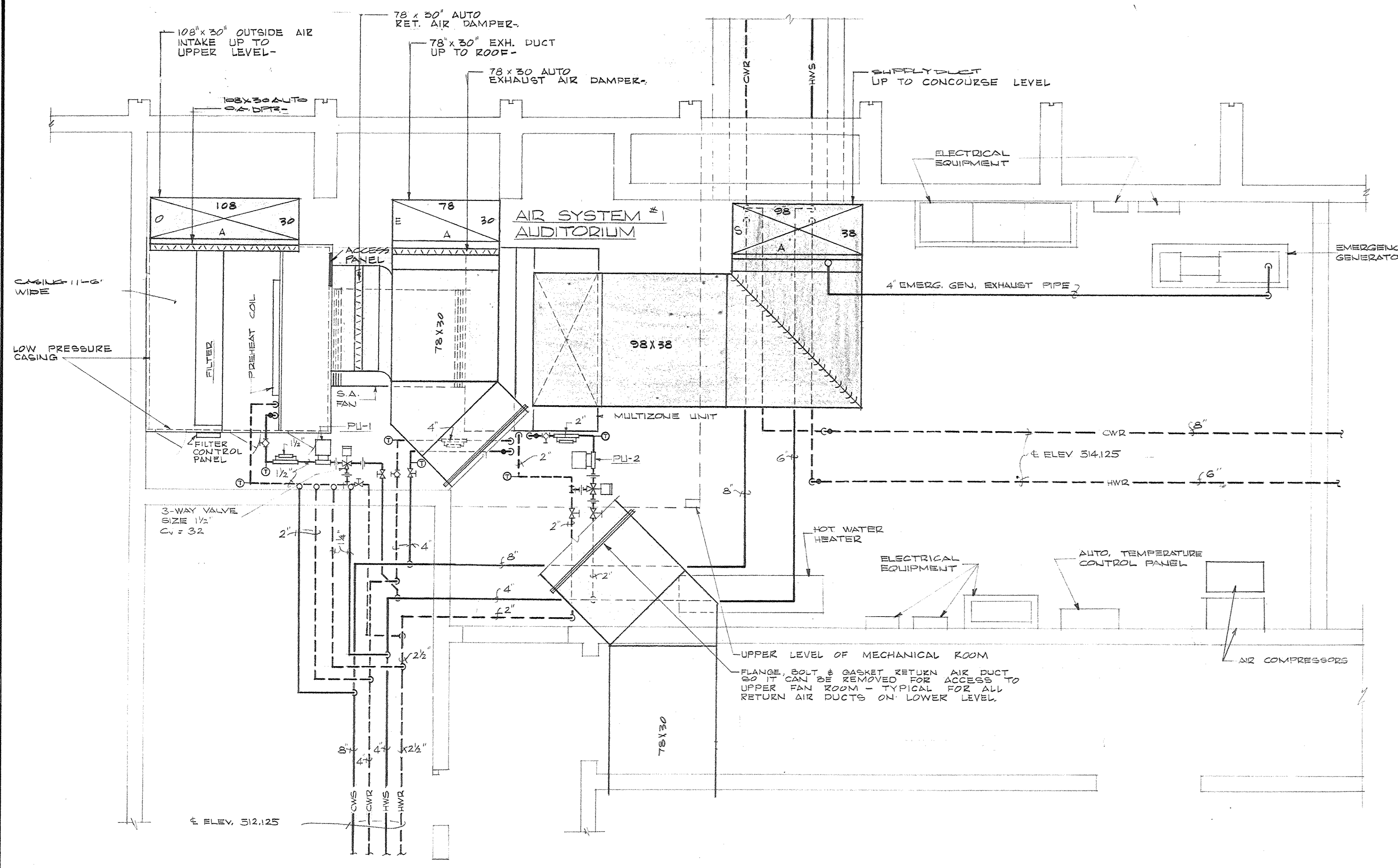
LINEAR SUPPLY AIR DIFFUSER

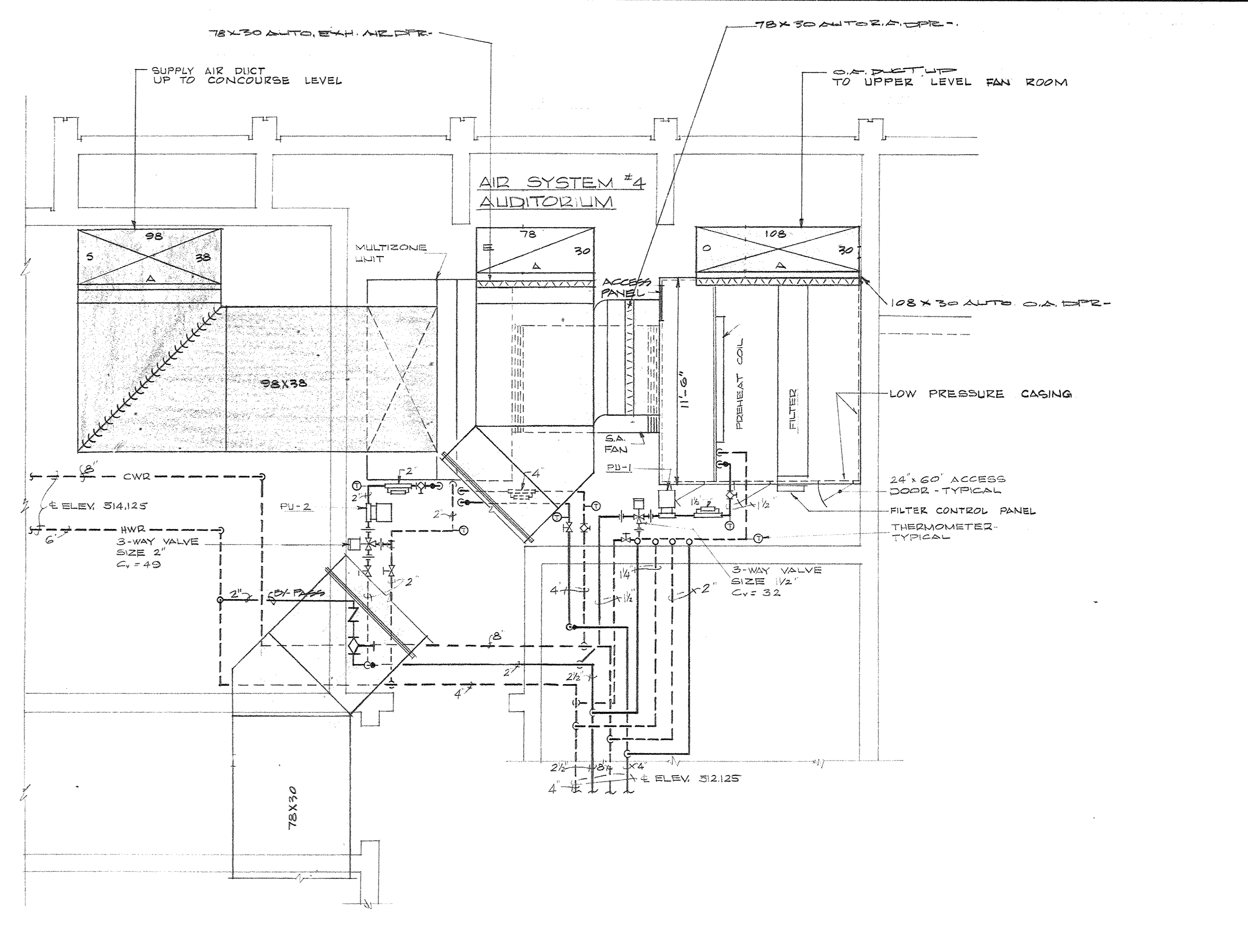

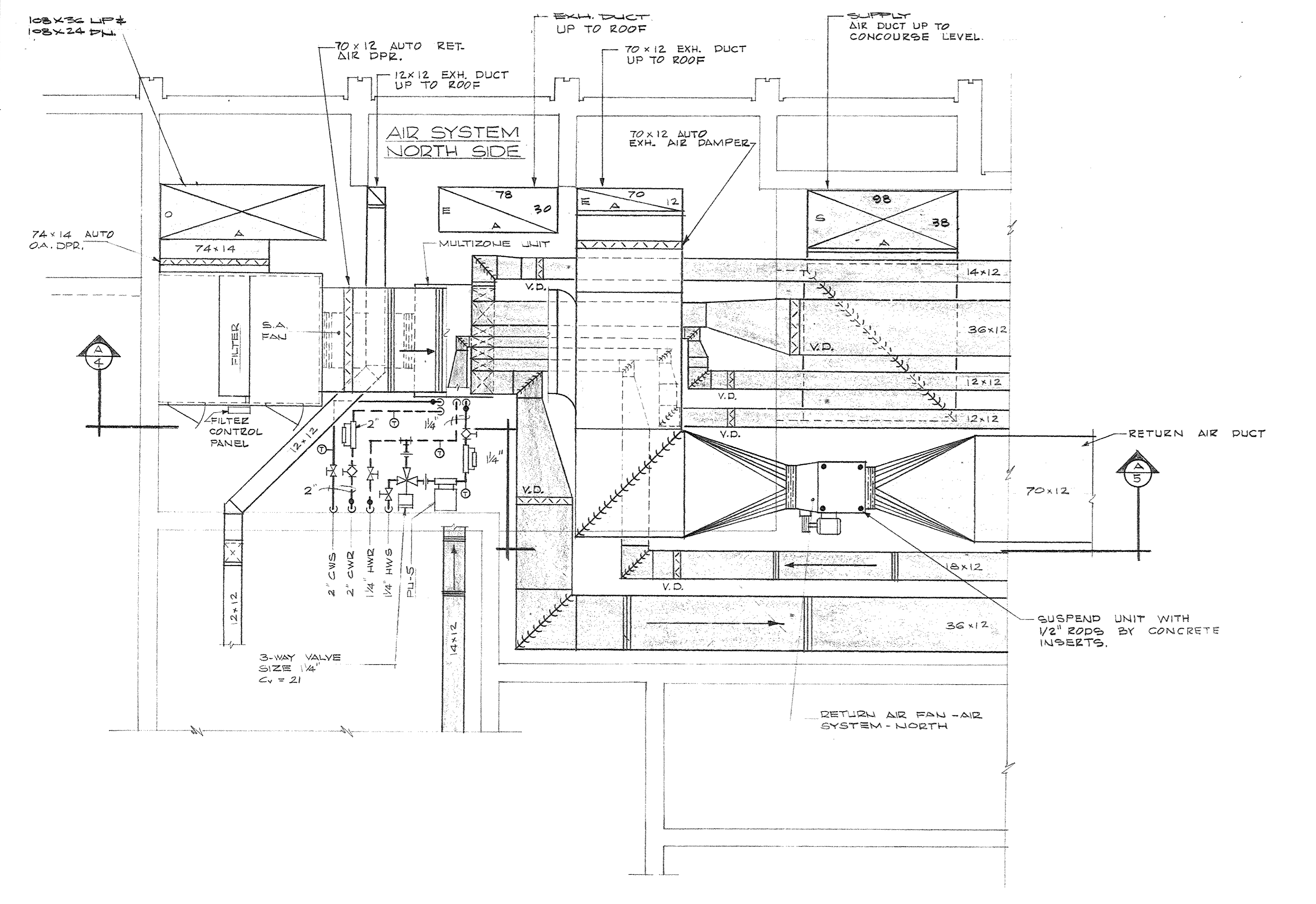
HEATING AND AIR CONDITIONING PLAN - CONCOURSE LEVEL



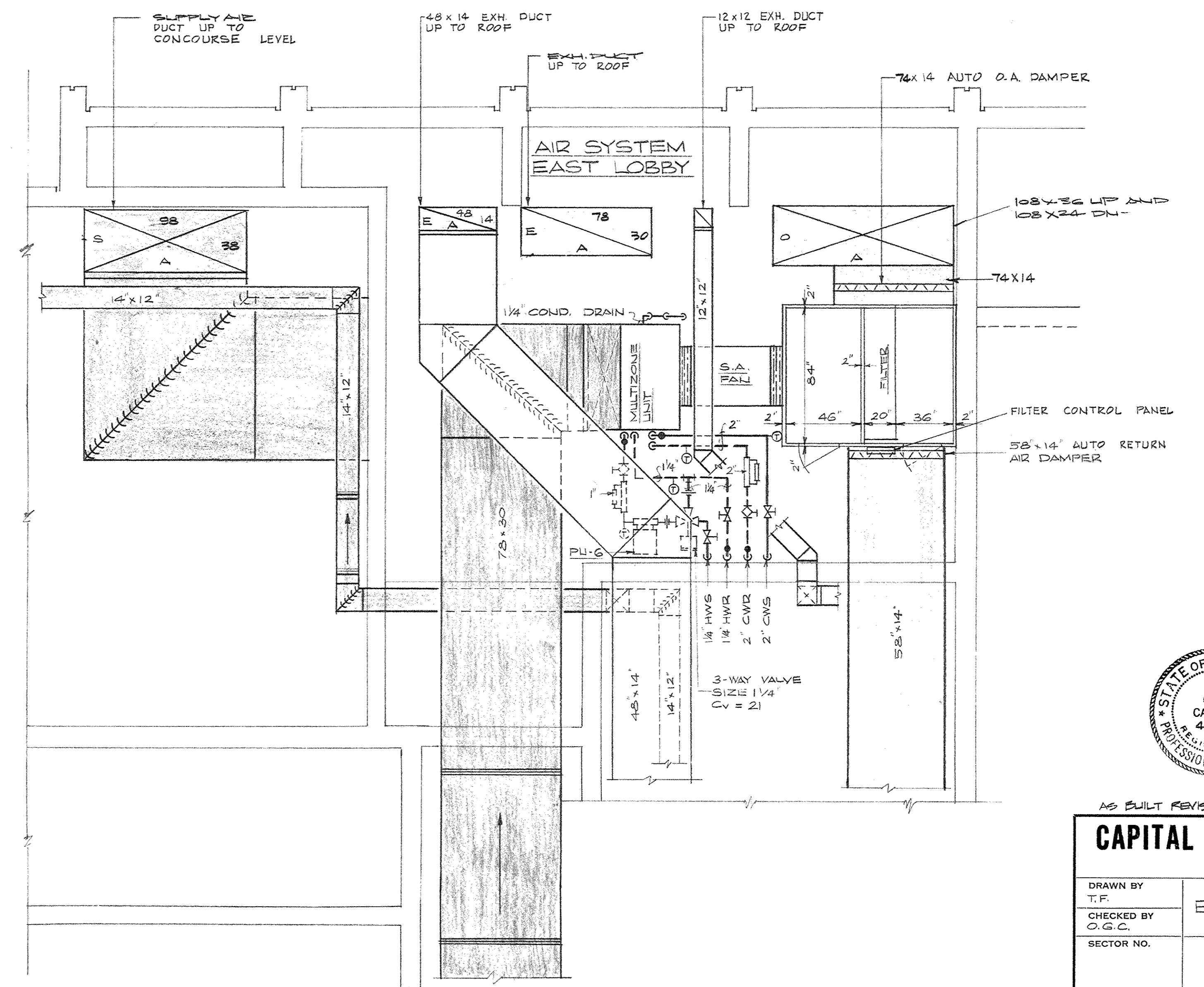

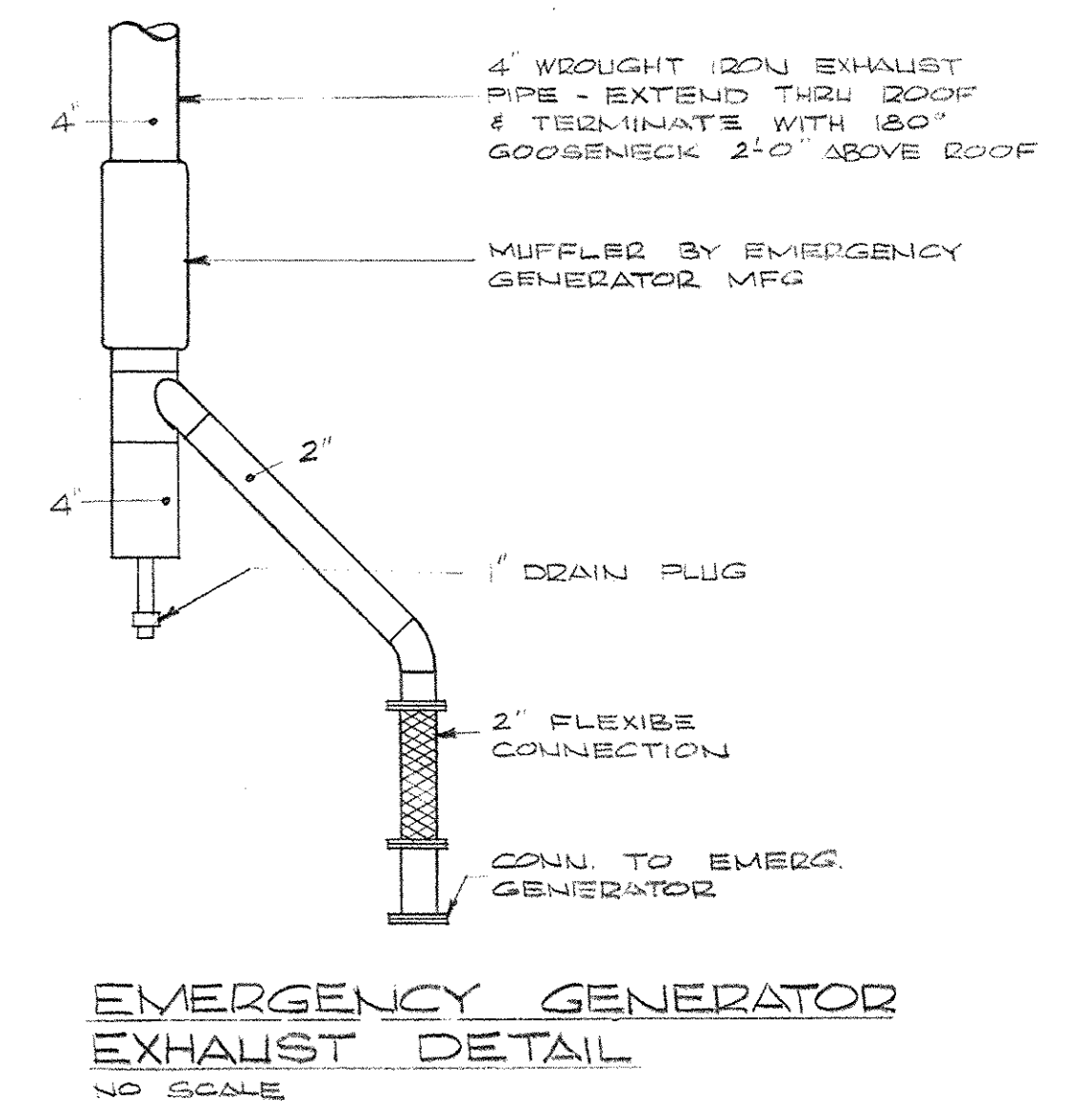
ENLARGED PLAN - LOWER LEVEL - FAN ROOM # 33

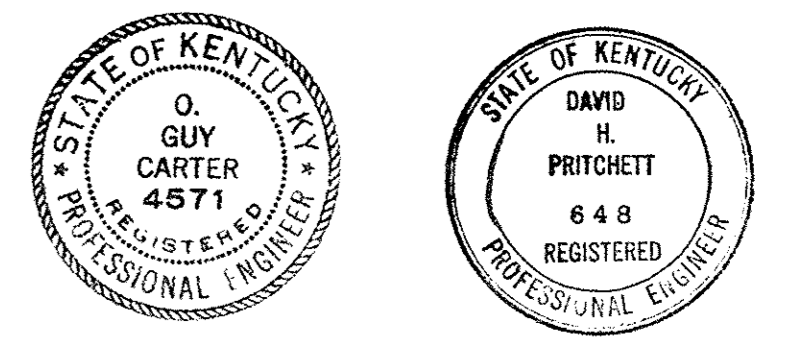
ENLARGED PLAN - UPPER LEVEL - MECHANICAL ROOM # 41

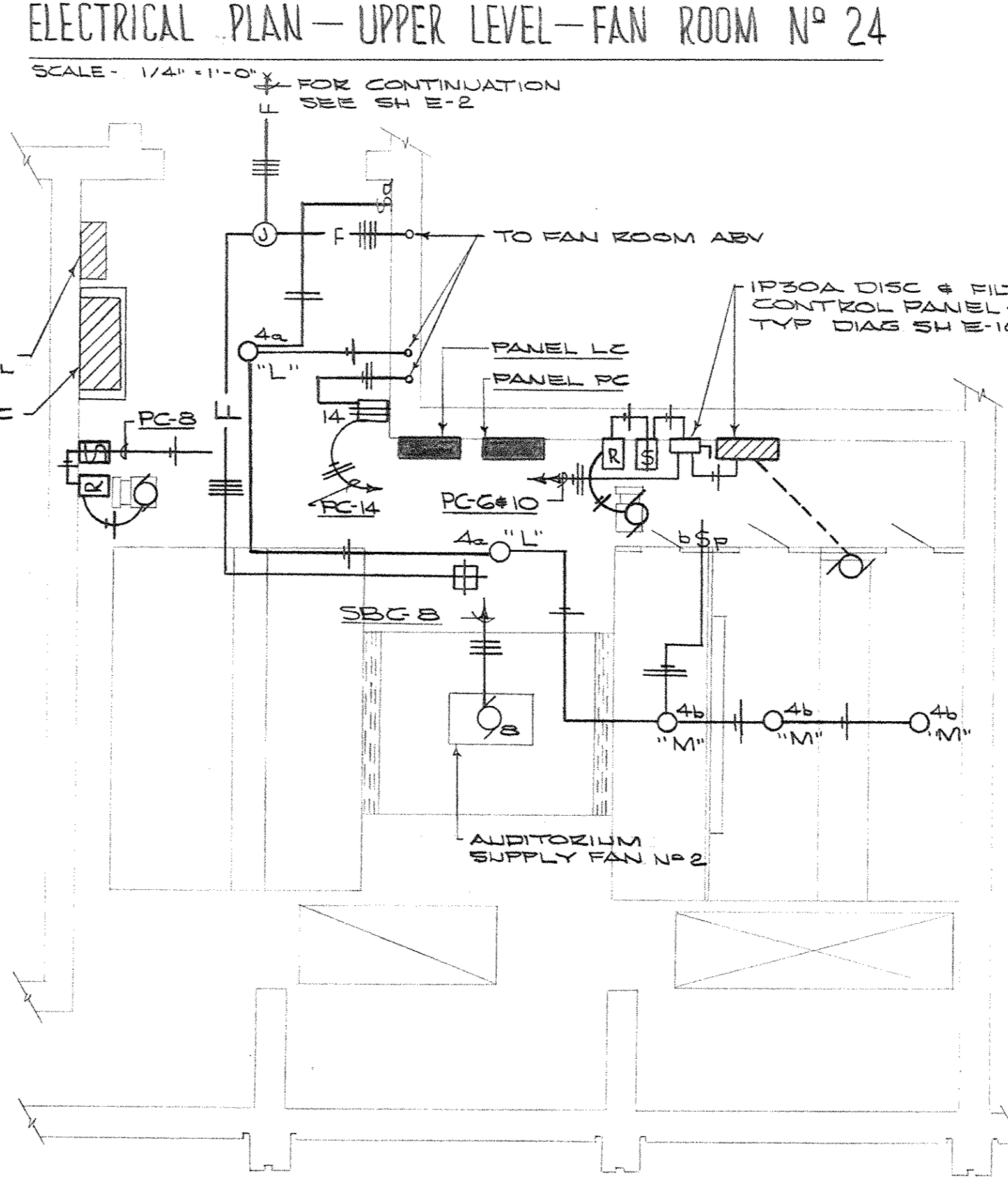




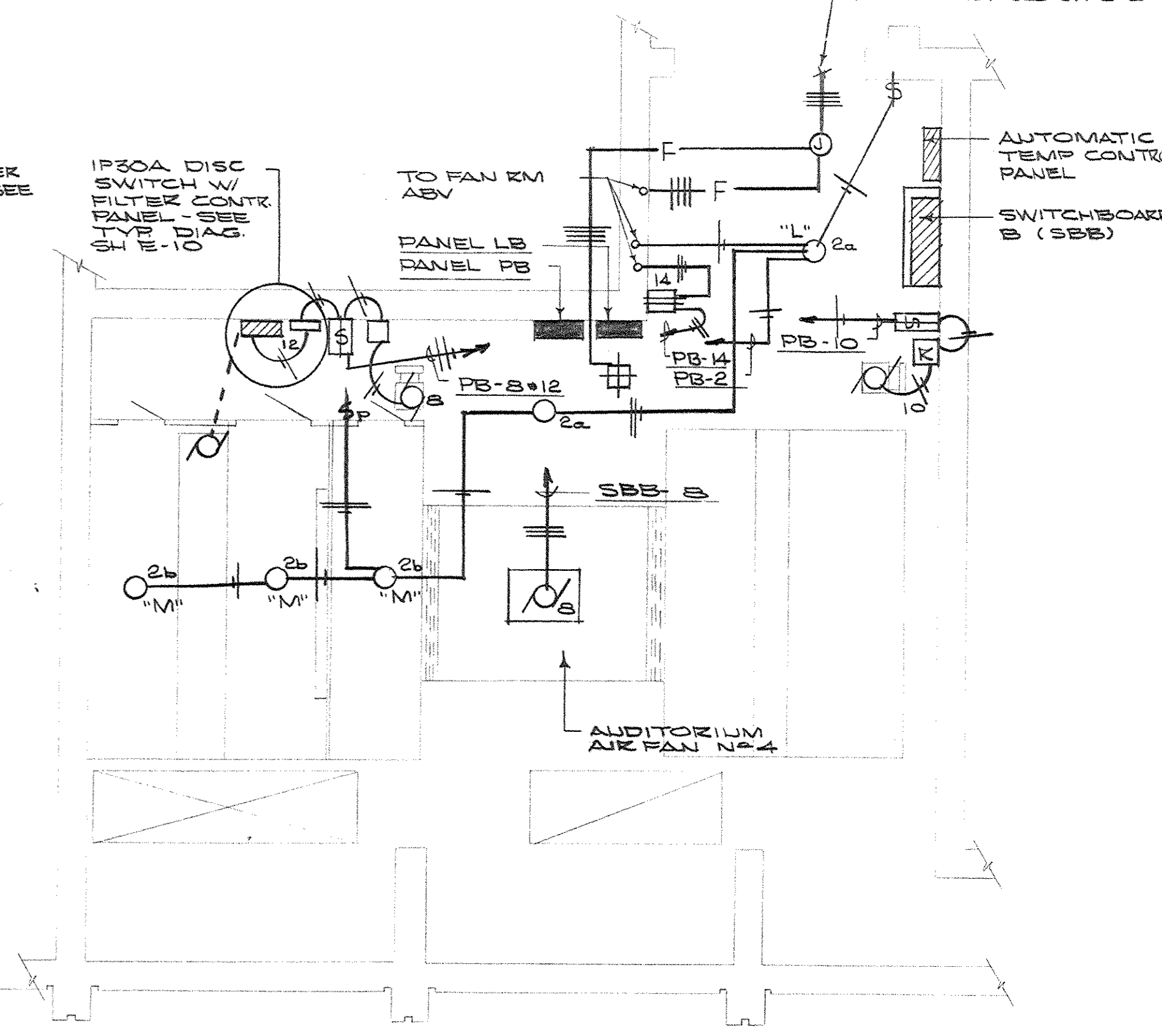
ELECTRICAL PLAN - LOWER LEVEL - MECHANICAL ROOM No. 41

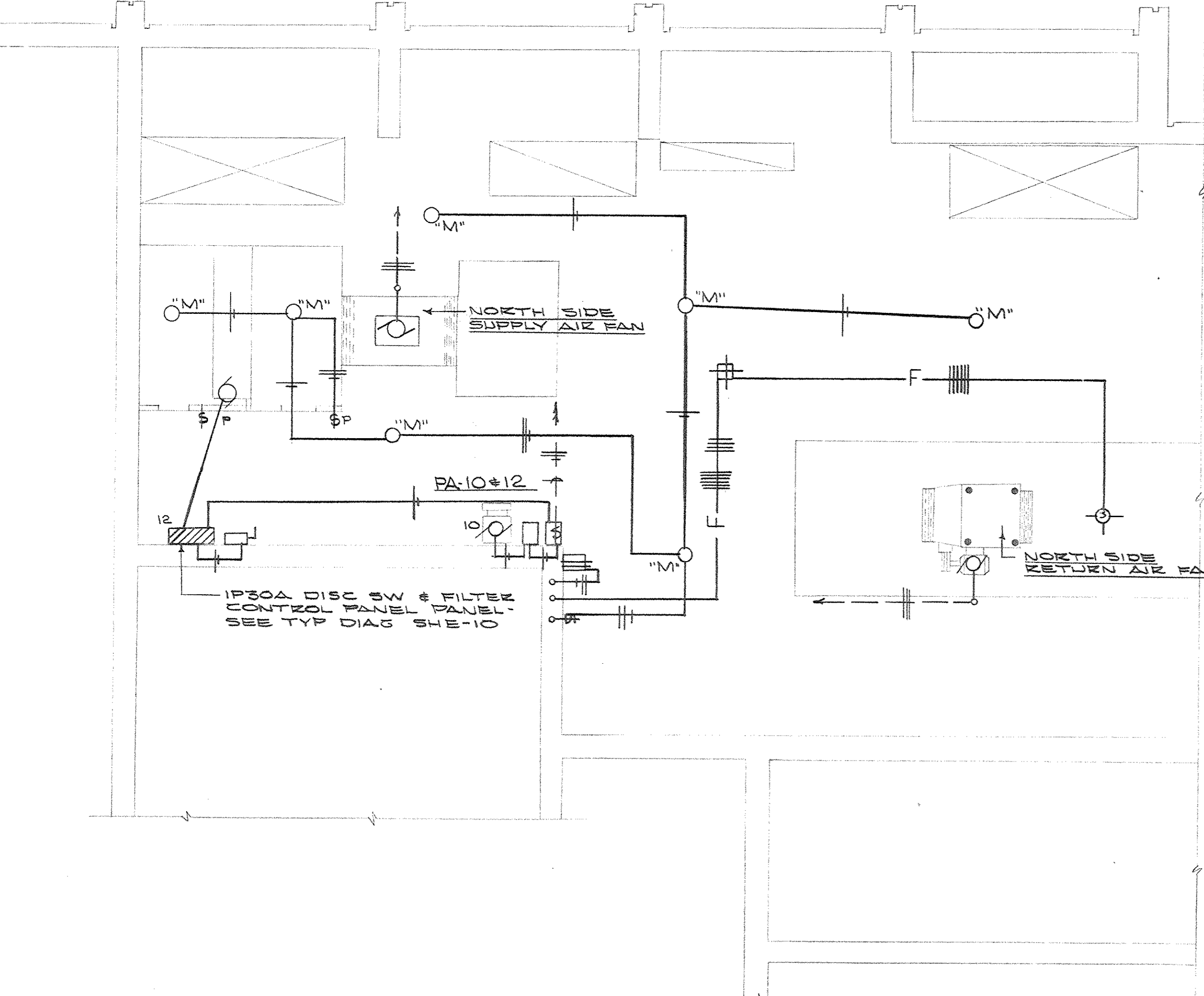
ELECTRICAL PLAN - UPPER LEVEL - FAN ROOM No. 5

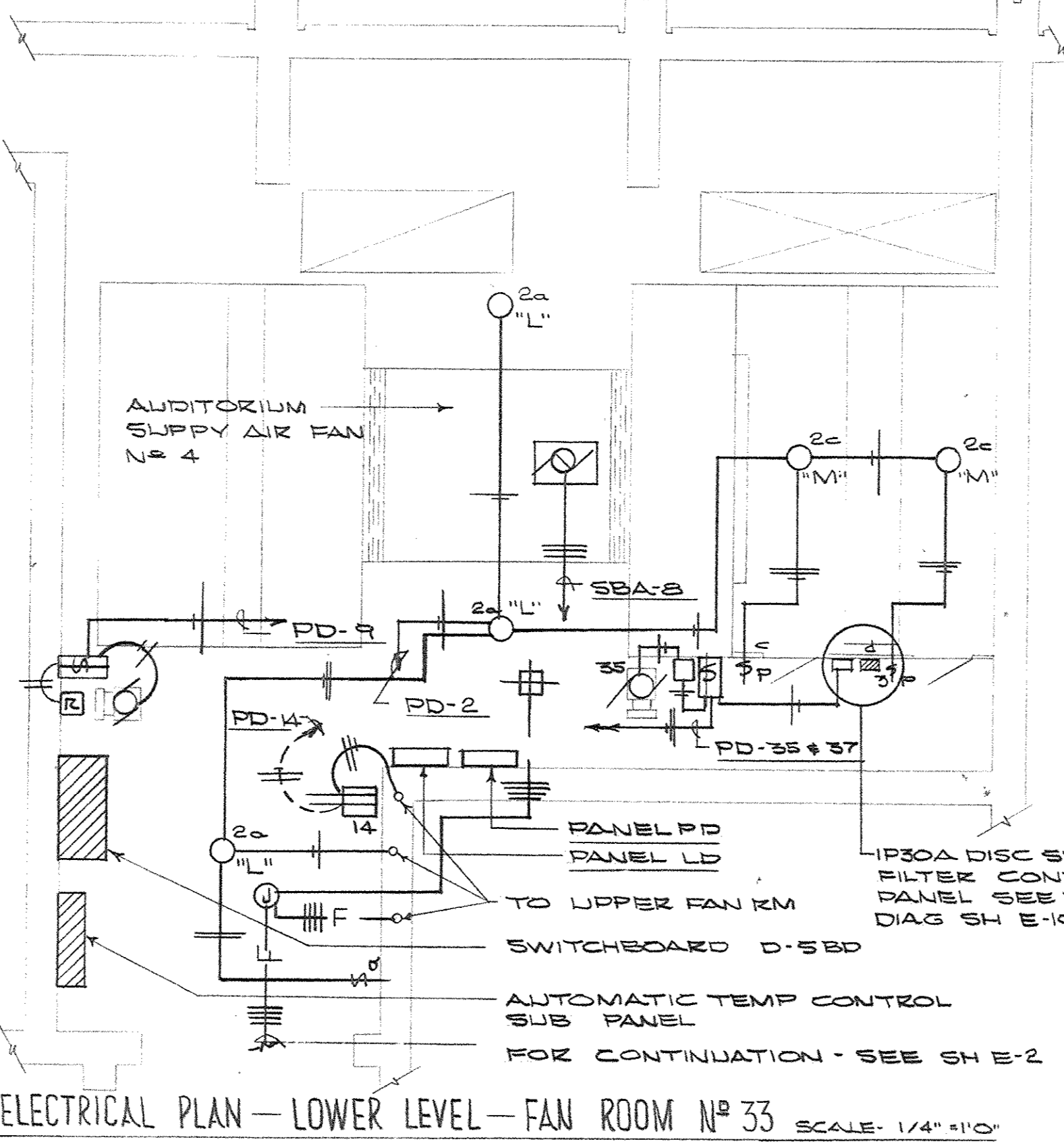


ELECTRICAL PLAN - LOWER LEVEL - FAN ROOM No. 5

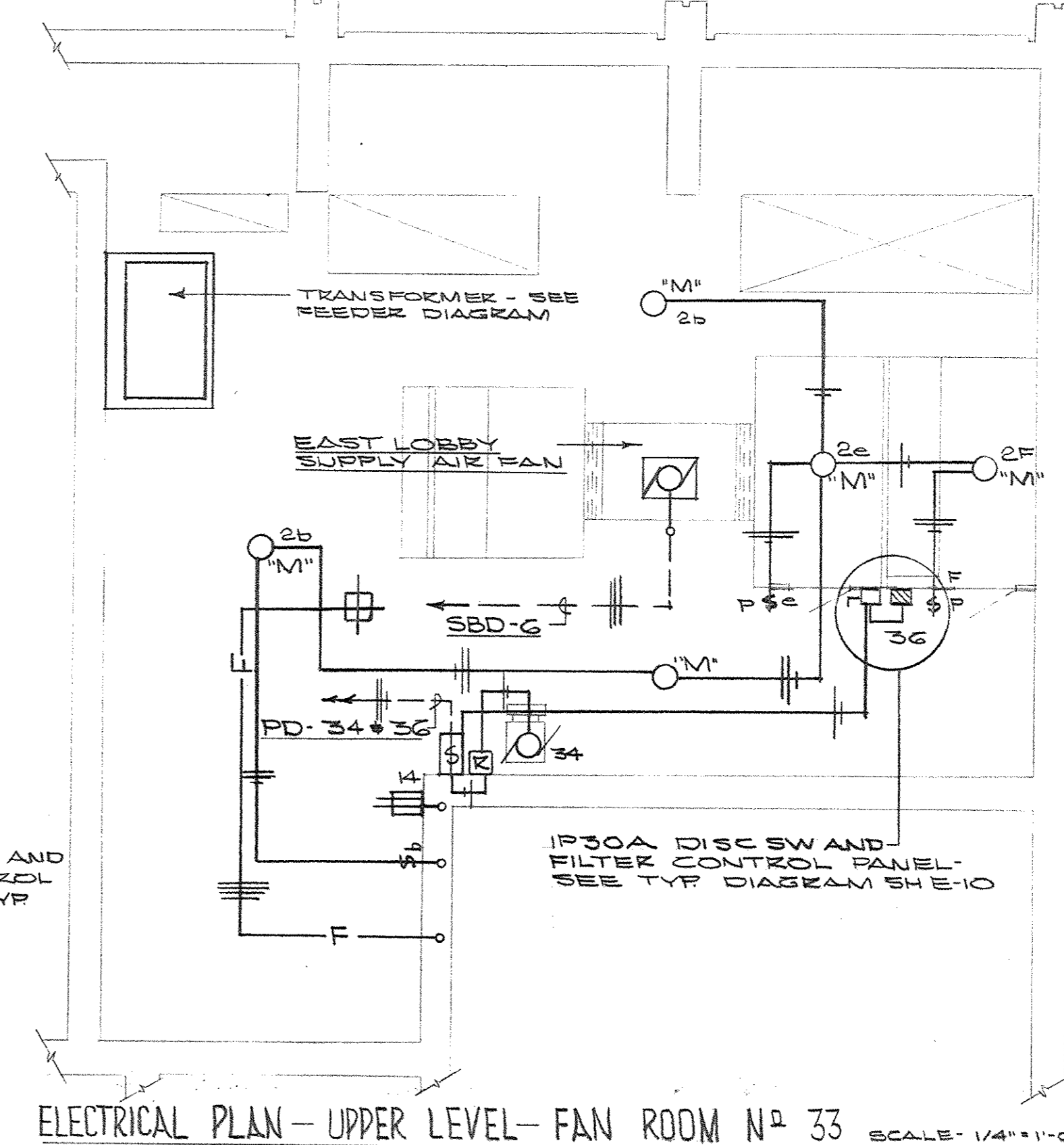


ELECTRICAL PLAN - UPPER LEVEL - MECHANICAL ROOM No. 41

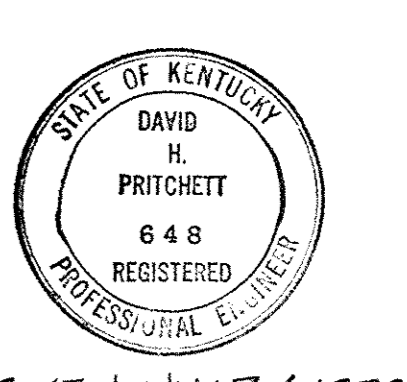

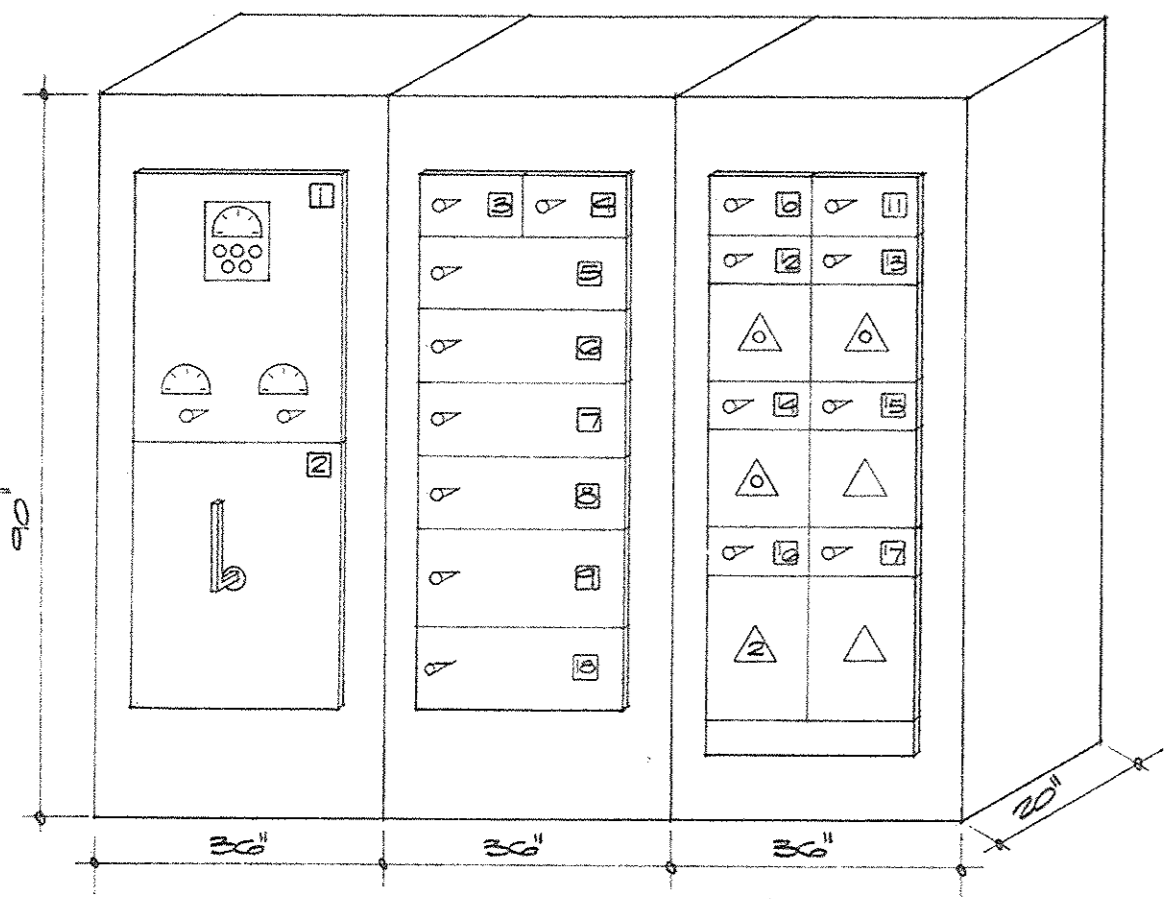


ELECTRICAL PLAN - UPPER LEVEL - FAN ROOM No. 33

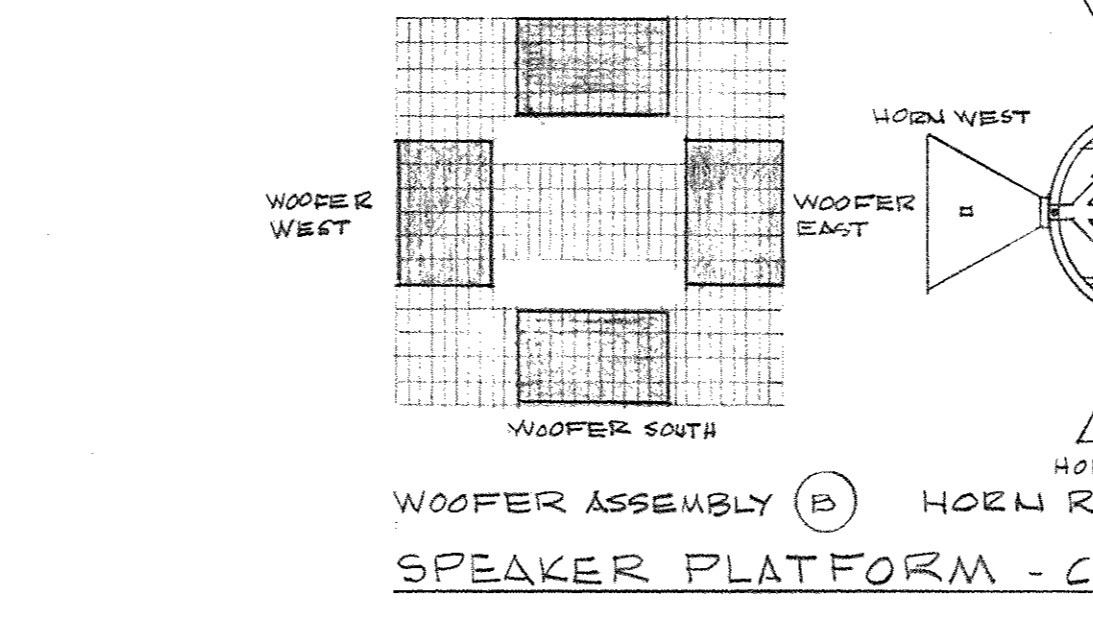


DETAIL - FIXTURE ASSEMBLY "B"
