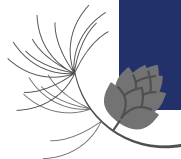

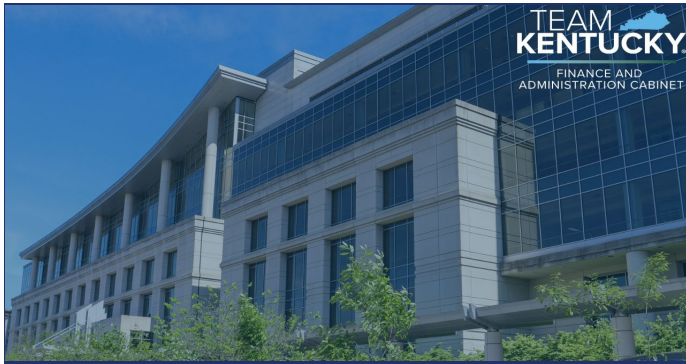
## EXECUTIVE DIRECTOR'S CORNER

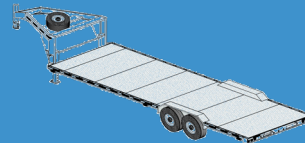
