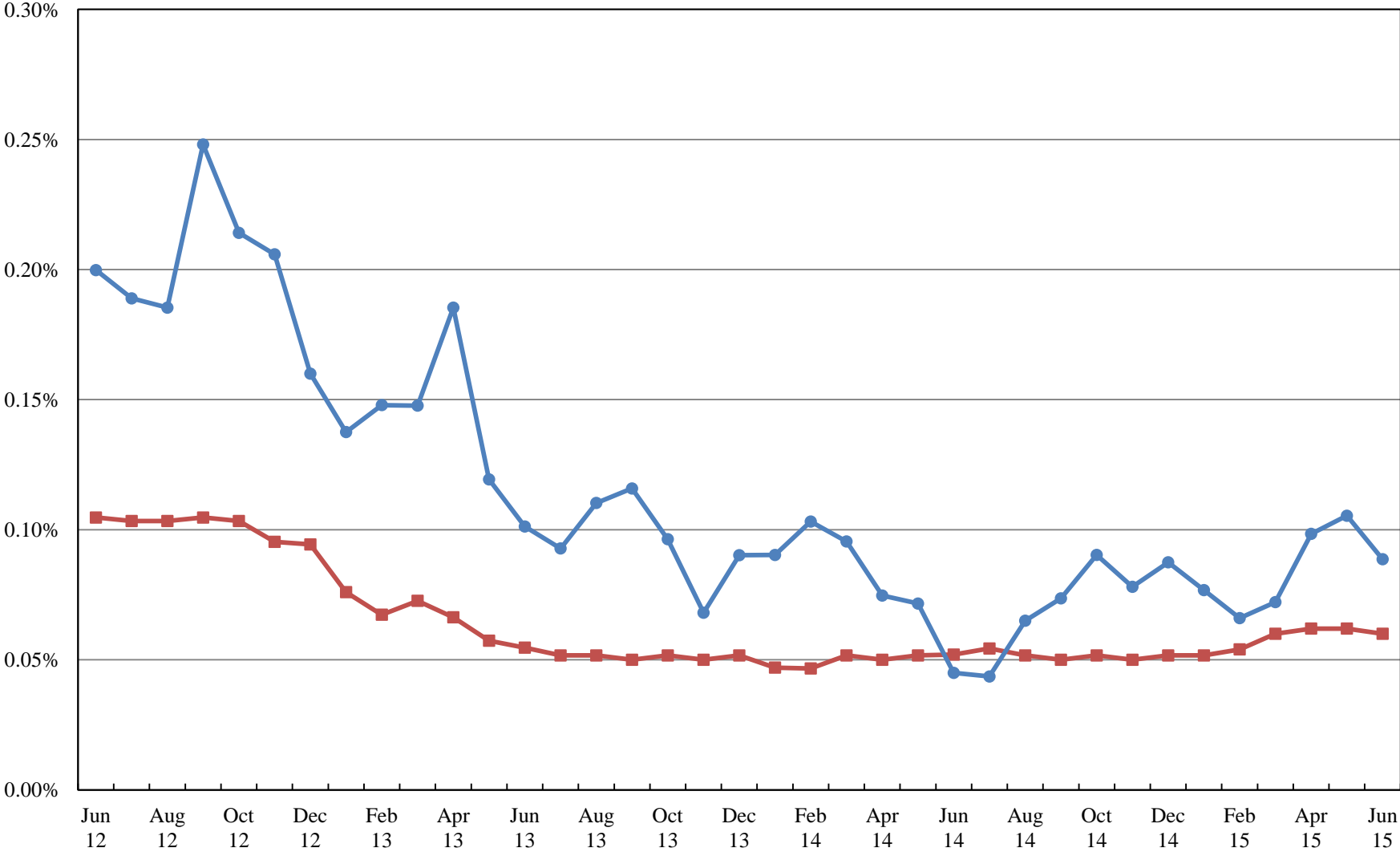

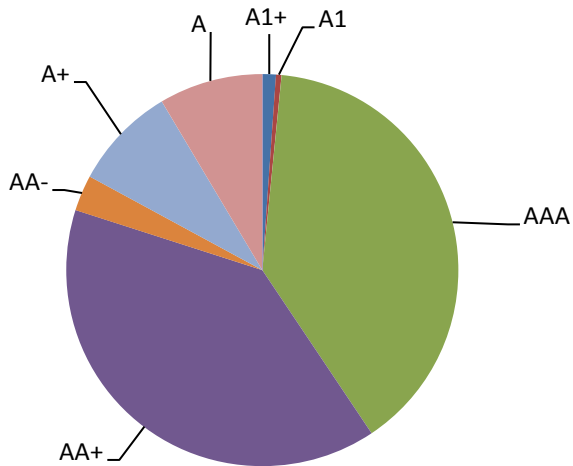

AS OF JUNE 30, 2015**

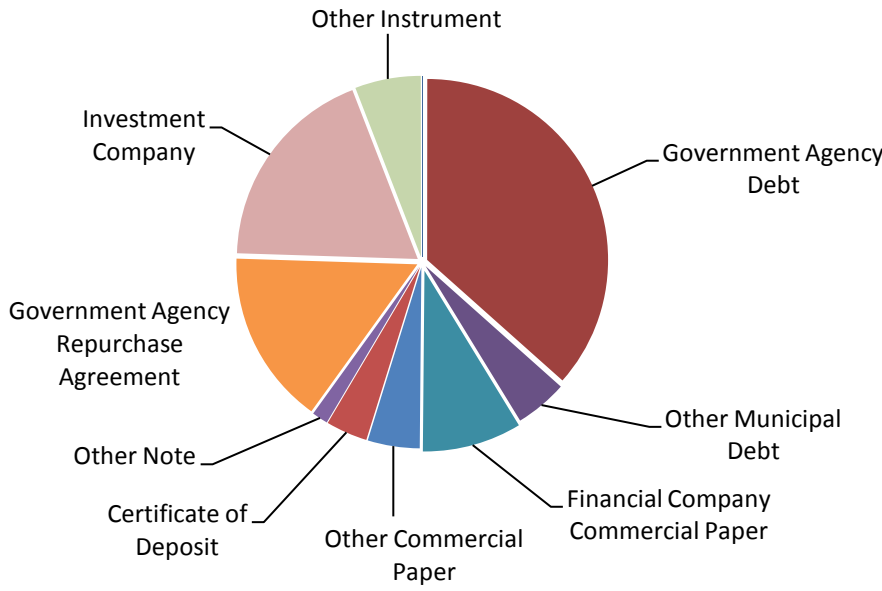
