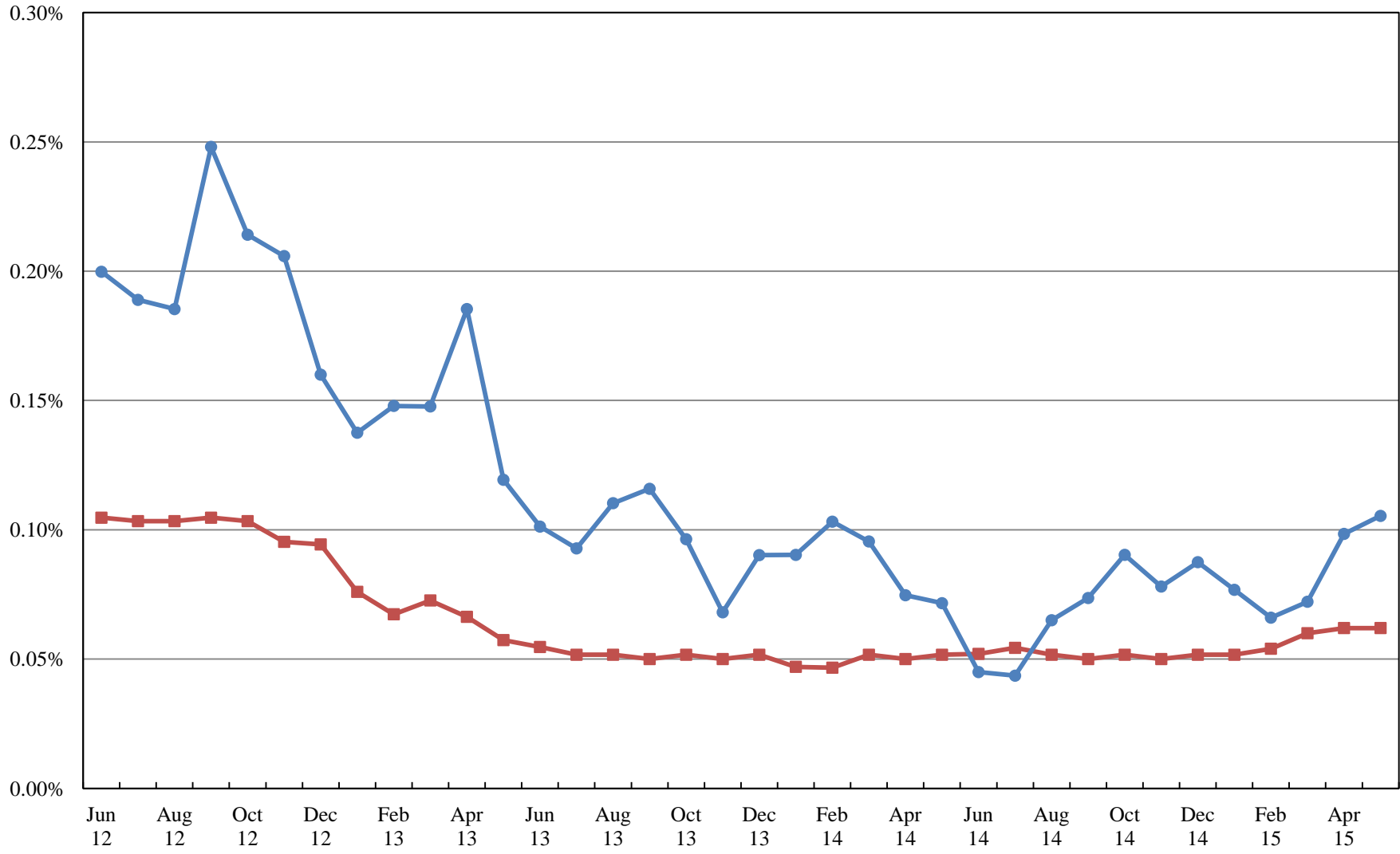

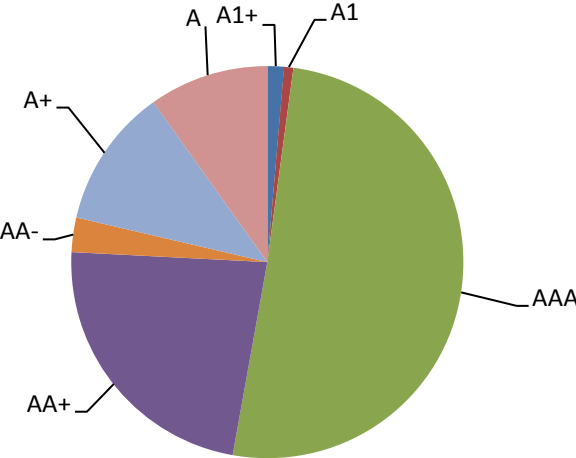

AS OF MAY 31, 2015**

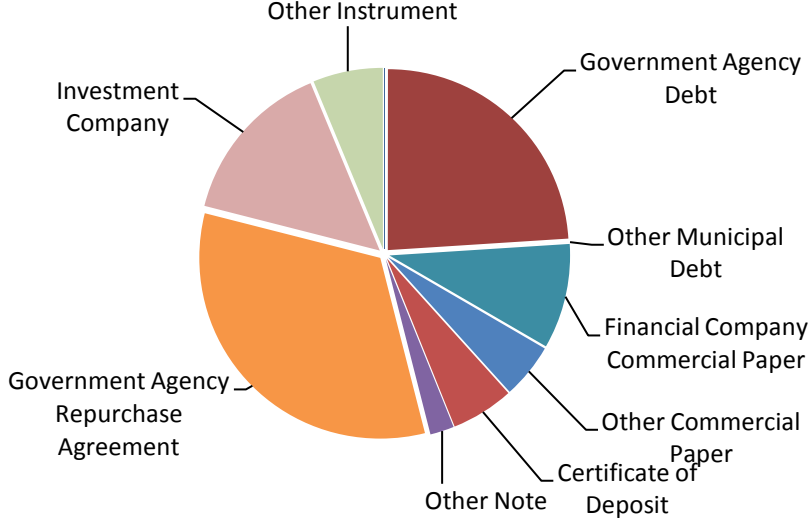
