

Kentucky Governmental Utilities

The following is an unofficial list of Kentucky governmental utilities that are covered for social security purposes pursuant to an agreement executed under Section 218 of the Social Security Act. The execution of a Section 218 agreement indicates that some, but perhaps not all, services performed by the entity's employees are covered for social security purposes. The 218 agreement, in some cases, excludes from social security services that are performed by certain classes of employees.

The actual coverage documentation for Kentucky governmental employers is on file with the Social Security Coverage and Reporting Branch in Frankfort, Kentucky.
