 - ix. Vehicles shall be properly mufflered and shall stay on paved roads. An exception shall be made for the use of power-driven mobility devices, such as golf carts, by a person with a mobility disability who is using a motorized vehicle for travel to or from campground facilities; and has proof of disability such as (a) an

appropriate identification card or vehicle license plate or (b) states verbally that they have a mobility disability and has not been observed performing an activity that contradicts that statement. Such exceptions must also be in accordance with current department regulation 301 KAR 3:012. No ATVs or go-carts permitted.
